Dear Mr. President:

Transmitted herewith are proposed changes to the General Appropriations Act (Senate Bill No. 355). This is the first of several scheduled messages to bring expenditures in line with revenues and to balance the general fund financial plan without using the Hawaii Hurricane Relief Fund. Included in this message are operating budget adjustments for the following departments and agencies: Departments of Budget and Finance, Defense, Hawaiian Home Lands, Human Resources Development and Taxation, the Office of the Governor, and the Hawaii Health Systems Corporation. Your favorable consideration of the attached items is requested.

As outlined by the Director of Finance, adjustments to the prior Administration's budget submittal include:

- 1. Reductions to departmental discretionary expenditures that were part of the FY 03 budget base.
- 2. Deletion of discretionary add-ons proposed by the prior Administration.
- 3. Additions to reflect new priorities and to fund certain special-funded programs that we are proposing to repeal the respective special fund.
