## A BILL FOR AN ACT

RELATING TO THE HAWAII TOURISM AUTHORITY.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	THE STATE OF HAWAII:
1	PART I
2	SECTION 1. Chapter 201B, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	"S201B- Authority, private attorneys. (a) The board
6	may appoint or retain by contract one or more attorneys who are
7	independent of the attorney general to provide legal services
8	for the board solely in cases of contract negotiations in which
9	the attorney general lacks sufficient expertise; provided that
10	the independent attorney shall consult and work in conjunction
11	with the designated deputy attorney general assigned to the
12	Hawaii tourism authority.
13	(b) The board may fix the compensation of the attorneys
14	appointed or retained pursuant to this section. Attorneys
15	appointed or retained by contract shall be exempt from chapters
16	76, 78, and 88."

The University of Hawaii, the Hawaii tourism authority, and the 4 department of education shall preaudit all proposed payments to 5 determine the propriety of expenditures and compliance with 6 applicable laws, executive orders, and rules as may be in 7 effect. The University of Hawaii, the Hawaii tourism authority, 8 and the department of education shall make disbursements for 9 10 operating expenses from the amounts released by the comptroller 11 and maintain records and documents necessary to support those disbursements at times mutually agreed upon by the university 12 president, the executive director of the Hawaii tourism 13 authority, or the superintendent of education, as applicable, 14 and the comptroller; provided that when requested by the 15 university, the Hawaii tourism authority, or department of 16 education, the comptroller shall make all disbursements for the 17 18 university, the Hawaii tourism authority, or department of education, as applicable, subject to available allotment. Funds 19 20 released pursuant to this section shall be deposited by the university, the Hawaii tourism authority, or department of 21 education, as applicable, in accordance with the provisions 22

- 6 comptroller shall determine the forms required to adequately
- 7 supply accounting and statistical data for the state government.
- 8 The comptroller shall require heads of departments and
- 9 establishments of the state government to submit proposed new
- 10 forms or proposed changes in current business and accounting
- 11 forms for review and approval before ordering the same printed;
- 12 except that the University of Hawaii, the Hawaii tourism
- 13 authority, and the department of education shall be subject to
- 14 this requirement only with respect to uniform business and
- 15 accounting forms of statewide use in the State's accounting
- 16 system. All standard state forms shall be classified, numbered,
- 17 and standardized in design, dimensions, color, and grade of
- 18 paper and recorded in a catalogue of accounting and statistical
- 19 forms by the comptroller."
- SECTION 6. Section 201B-2, Hawaii Revised Statutes, is
- 21 amended by amending subsection (f) to read as follows:

- 1 "(f) The board shall appoint an executive director, exempt
- 2 from chapters 76, [and] 78, and 88 who shall oversee the
- 3 authority staff; provided that the compensation package,
- 4 including salary, shall not exceed [fifteen] nine per cent of
- 5 the [3.5] five per cent authorized for administrative expenses
- 6 under section 201B-11(c); and provided further that the
- 7 compensation package shall not include private sector moneys or
- 8 other contributions. The board shall set the executive
- 9 director's duties, responsibilities, holidays, vacations,
- 10 leaves, hours of work, and working conditions. It may grant
- 11 such other benefits as it deems necessary.
- The board may appoint a sports coordinator, exempt from
- chapters 76, 78, and 88, who shall provide management services
- 14 for all sporting events supported through the authority."
- SECTION 7. Section 201B-11, Hawaii Revised Statutes, is
- 16 amended as follows:
- 1. By amending subsection (a) to read:
- (a) There is established in the state treasury the tourism
- 19 special fund, into which shall be deposited:
- 20 (1) A portion of the revenues from any transient
- 21 accommodations tax, as provided by section 237D-6.5;

19	SECTI	ON 8. The Hawaii tourism authority was established in
20	1998 to im	plement the recommendations of the economic
21		tion task force relating to tourism and economic
22	developmen	t to coordinate the development, marketing, and

- 1 research of the tourism industry in a manner consistent with the
- 2 needs of the State.
- 3 The Hawaii tourism authority's initial budget was required
- 4 to fund eighteen months of the Hawaii visitors and convention
- 5 bureau's marketing contract (July 1, 1998, to December 31, 1998,
- 6 and January 1, 1999, to December 31, 1999) with funding for
- 7 twelve months. This situation caused the authority to use
- 8 future budgets to make up for the appropriation shortfall, which
- 9 in the authority's initial budget year amounted to \$27,000,000.
- 10 This condition continues today, where the fiscal year budgets of
- 11 the Hawaii tourism authority are inadequate to cover the
- 12 calendar year contracts for marketing the State of Hawaii.
- The purpose of this part is to appropriate funds from the
- 14 tourism special fund to allow the Hawaii tourism authority to
- 15 begin correcting this fiscal anomaly.
- 16 SECTION 9. There is appropriated out of the tourism
- 17 special fund the sum of \$8,000,000 or so much thereof as may be
- 18 necessary for fiscal year 2004-2005 to improve the operational
- 19 and financial efficiency of the Hawaii tourism authority;
- 20 provided that the sum appropriated shall be in addition to the
- 21 sums appropriated out of the tourism special fund in the
- 22 supplemental appropriations Act or any other Act.

- 1 The sum appropriated shall be expended by the Hawaii
- 2 tourism authority for the purposes of this part.
- 3 SECTION 10. The Hawaii tourism authority may amend
- 4 existing contracts to conform to the purposes of this part.
- 5 SECTION 11. The Hawaii tourism authority shall report to
- 6 the legislature no later than January 15, 2005, on the details
- 7 of expenditures of moneys appropriated under this part.
- 8 SECTION 12. This part shall not be construed to impair any
- 9 contract existing as of the effective date of this Act.
- 10 PART III
- 11 SECTION 13. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- SECTION 14. This Act shall take effect on upon its
- 14 approval; provided that:
- 15 (1) The amendments made to sections 40-1, 40-4, and 40-6,
- 16 Hawaii Revised Statutes, by part I of this Act shall
- not be repealed when those sections are reenacted on
- June 30, 2005, by section 24 of Act 115, Session Laws
- of Hawaii 1998;
- (2) Part I shall be repealed on June 30, 2007, and
- 21 sections 28-8.3, 40-1, 40-4, and 40-6, 201B-2, and
