A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HEALTH FOR EARLY INTERVENTION SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Although funds were appropriated to the
- 5 department of health for early intervention services for the
- 6 period beginning July 1, 2005 and ending June 30, 2006, the
- 7 department of health has a critical need for additional funds.
- 8 On May 31, 2005, the State of Hawaii was deemed in
- 9 compliance with the Felix Consent Decree, marking the end of
- 10 federal court oversight for services, including early
- 11 intervention services. The department of health must continue
- 12 to carry out its obligations to provide early intervention
- 13 services for children age zero to three years with a
- 14 developmental delay or biological or environmental risk, as
- 15 mandated by part C of the Individuals with Disabilities
- 16 Education Improvement Act of 2004 (P.L. 108-446), sections 321-
- 17 351 to 321-357, Hawaii Revised Statutes, and the Hawaii early

- 1 intervention state plan. The department must ensure that
- 2 eligible children and their families receive the services
- 3 mandated by part C of the Individuals with Disabilities
- 4 Education Improvement Act of 2004 that are identified on their
- 5 individual family support plans.
- 6 Existing funds will be expended before the end of this
- 7 fiscal year, due to increased costs for early intervention
- 8 purchase-of-service programs to evaluate additional children and
- 9 serve them in "natural environments" as required by the
- 10 Individuals with Disabilities Education Improvement Act of 2004.
- 11 These purchase-of-service programs are providing an increased
- 12 number of multi-disciplinary comprehensive developmental
- 13 evaluations of a child's cognitive, physical, communication,
- 14 social or emotional, and adaptive development, as required by
- 15 part C of the Individuals with Disabilities Education
- 16 Improvement Act of 2004, P.L. 108-446, due to an increased
- 17 number of children referred by public health nurses and healthy
- 18 start programs. To serve more children, current programs have
- 19 expanded and three new purchase-of-service programs in windward,
- 20 central, and leeward Oahu have been added. These programs serve
- 21 additional children who previously received therapy services
- 22 from fee-for-service providers and care coordination from early

- 1 intervention section, early childhood services programs, public
- 2 health nurses, or healthy start; and additional children under
- 3 age three years who are confirmed victims of child abuse or
- 4 neglect, as required by the Child Abuse Prevention and Treatment
- 5 Act and the Individuals with Disabilities Education Improvement
- 6 Act of 2004. The Individuals with Disabilities Education
- 7 Improvement Act of 2004 also requires a family-centered but more
- 8 costly approach of providing services in "natural environments"
- 9 or community-based settings, such as at families' homes,
- 10 community preschools, and parks which increases travel time for
- 11 service providers to reach the "natural environment", and
- 12 necessitates a smaller caseload, an increased number of
- 13 providers, and results in increased costs per child.
- 14 The purpose of this Act is to increase the authorized
- 15 general fund appropriation by \$3,200,928, for early intervention
- 16 services in the department of health for fiscal year 2005-2006.
- 17 SECTION 3. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$3,200,928, or so
- 19 much thereof as may be necessary, for fiscal year 2005-2006 to
- 20 carry out the purposes of this Act.
- 21 SECTION 4. The sum appropriated shall be expended by the
- 22 department of health.

SECTION 5. This Act shall take effect upon its approval.
