RELATING TO FEES FOR ELECTRONIC FILING, SIGNING, SERVING, CERTIFICATION, AND VERIFICATION OF COURT DOCUMENTS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 230, Session Laws of Hawaii 2004, is
- 2 amended by amending section 6 to read as follows:
- 3 "SECTION 6. This Act shall take effect on July 1, 2004;
- 4 provided that on [June 30, 2007,] December 31, 2008, sections 2,
- 5 3, and 4 of this Act shall be repealed and sections 601-3.7,
- 6 607-1, and 607-2, Hawaii Revised Statutes, are reenacted in the
- 7 same form in which they read on June 30, 2004."
- 8 SECTION 2. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 3. This Act shall take effect upon its approval.
