BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	amended b	y amending the definition of "neighborhood electric
3	vehicle"	to read as follows:
4	""Ne	ighborhood electric vehicle" means a self-propelled
5	electrica	lly powered motor vehicle to which all of the following
6	apply:	
7	(1)	The vehicle is emission free;
8	[-(2)	The vehicle is designed to carry four or fewer
9		persons;
10	(3)]	(2) The vehicle is designed to be and is operated at
11		speeds of twenty-five miles per hour or less;
12	[-(4)-]	(3) The vehicle has [at least] four wheels in contact
13		with the ground;
14	[-(5)-]	(4) The vehicle has [an unladen weight] a gross
15		vehicle weight rating of less than [one thousand eight
16		hundred] two thousand five hundred pounds; and
17	[(6)]	(5) The vehicle conforms to the minimum safety
18		equipment requirements as adopted in the Federal Motor

1	Vehicle Safety Standard No. 500, Low Speed Vehicles
2	(49 C.F.R. 571.500)."
3	SECTION 2. Statutory material to be repealed is bracketed
4	and stricken. New statutory material is underscored.
5	SECTION 3. This Act shall take effect upon its approval.
