A BILL FOR AN ACT

RELATING TO THE ONE CALL CENTER ADVISORY COMMITTEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 269E-4, Hawaii Revised Statutes, is 1 amended by amending subsection (a) to read as follows: 2 "[+](a)[+] The commission shall establish a one call 3 center advisory committee as a governmental entity as defined 4 under chapter 662D to advise the commission in implementing this 5 chapter. The committee shall consist of [fifteen] seventeen 6 voting members and one ex officio nonvoting member. Of the 7 voting members: 8 [Nine] Eleven shall be appointed by the commission to 9 (1) serve until successors are appointed by the 10 commission. The appointments shall be as follows: 1 10 One from the gas utility industry; 12 (A) One from the electric utility industry; (B) 13 One from the telecommunications utility industry; 14 (C) One from the pipeline operator industry; 15 (D) Two from the General Contractors Association of 16 (E) Hawaii; 17

1		(F) Two from the Building Industry Association of
2		Hawaii; [and]
3		(G) One from the cable service industry;
4		(H) One from the water utility industry; and
5		(I) One from the wastewater industry.

8		county of Honolulu;
9	(3)	One shall be the representative of the county of
10		Hawaii designated by the mayor of the county of
11		Hawaii;
12	(4)	One shall be the representative of the county of Maui
13		designated by the mayor of the county of Maui;
14	(5)	One shall be the representative of the county of Kauai
15		designated by the mayor of the county of Kauai;
16	(6)	One shall be the director of the state department of
17		transportation, or the director's representative; and
18	(7)	One shall be the executive director of the division of
19		consumer advocacy, department of commerce and consumer
20		affairs, or the executive director's representative.
