A BILL FOR AN ACT

RELATING TO COUNTY FISCAL ADMINISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 46-41, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "S46-41 Budgets; financial records on fiscal year basis.
- 4 Except as otherwise provided in this chapter, all counties shall
- 5 maintain accounting and financial records on a fiscal year
- 6 basis, beginning on July 1 or another day of [one] a calendar
- 7 year and ending on [June 30] the appropriate day of the next
- 8 succeeding calendar year. Counties may prepare a budget for a
- 9 one- or two-year period; provided that accounting and financial
- 10 records are maintained on a fiscal year basis as described
- 11 above."
- 12 SECTION 2. Statutory material to be repealed is bracketed
- 13 and stricken. New statutory material is underscored.
- 14 SECTION 3. This Act shall take effect upon its approval
- 15 and shall apply to fiscal years beginning after December 31,
- 16 2005.
