A BILL FOR AN ACT

RELATING TO PUBLIC UTILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 269-3, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) The chairperson of the public utilities commission
4	may appoint and employ [such] clerks, stenographers, agents,
5	engineers, accountants, and other assistants for the public
6	utilities commission as the chairperson finds necessary for the
7	performance of the commission's functions and define their
8	powers and duties. The chairperson may appoint and, at
9	pleasure, dismiss a chief administrator[, research assistants,
10	economists, legal secretaries, enforcement officers, and [such]
11	hearings officers as may be necessary. Notwithstanding section
12	103D-209(b), the chairperson shall appoint one or more attorneys
13	independent of the attorney general who shall act as attorneys
14	for the commission and define their powers and duties and fix
15	their compensation. The chief administrator[, research
16	assistants, economists, legal-secretaries, enforcement officers,
17	hearings officers, and attorneys shall be exempt from chapter
18	76. Research assistants, economists, legal secretaries, utility

- 1 analysts, legal assistants, and enforcement officers may be
- 2 appointed with or without regard to chapter 76. Other employees
- 3 shall be appointed as may be needed by the chairperson in
- 4 accordance with chapter 76."
- 5 SECTION 2. The public utilities commission shall conduct
- 6 an in-depth review of its organization to develop a
- 7 comprehensive plan to restructure and supplement the commission
- 8 and its resources to function more effectively and efficiently
- 9 in light of, among other matters, changing regulatory
- 10 conditions, duties, and requirements and advances in technology;
- 11 and submit a report to the legislature no later than twenty days
- 12 before the convening of the regular session of 2007. In the
- 13 report, the public utilities commission shall specify the
- 14 specific types and numbers of positions, and the amounts
- 15 necessary to restructure the commission and supplement its
- 16 resources as may be necessary and appropriate; and propose any
- 17 necessary legislation.
- 18 SECTION 3. The division of consumer advocacy shall conduct
- 19 an in-depth review of its organization to develop a
- 20 comprehensive plan to restructure and supplement the division
- 21 and its resources to function more effectively and efficiently
- 22 in light of, among other matters, changing regulatory

- 1 conditions, duties, and requirements and advances in technology;
- 2 and submit a report to the legislature no later than twenty days
- 3 before the convening of the regular session of 2007. In the
- 4 report, the division of consumer advocacy shall specify the

- 9 SECTION 4. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 5. This Act shall take effect on July 1, 2006.
