# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that educational systems
- 2 today are not only faced with changing needs and growing
- 3 demands, but also with tighter budgets. To meet the challenge
- 4 of twenty-first century realities, educational systems, and the
- 5 leadership and management structures within them, must be
- 6 rethought.
- 7 With its multimillion-dollar annual budget, large consumer
- 8 base, and wide-reaching impact, the State of Hawaii department
- 9 of education is much like a large corporation. In these modern
- 10 times, most successful corporations are operated through the
- 11 leadership and management of individuals who lend their
- 12 expertise to steer businesses on the best possible course.
- 13 Corporations employ chief financial officers, for example, to
- 14 effectively manage their budgets and finances. These officers
- 15 play a critical role in determining business goals and the
- 16 ability to meet them by maximizing resources and ensuring
- 17 efficient operations from a financial perspective.

- 1 It is only reasonable that an institution as important as
- 2 the department of education--one that nurtures the future of our
- 3 children and state--be operated as would a successful
- 4 corporation, under the guidance of a chief financial officer to
- 5 work hand-in-hand with the superintendent.
- 6 There are many experts in our local business community who
- 7 agree that improving the administration of the department of
- 8 education is in order. The department needs a comprehensive
- 9 budgeting and accounting system that takes into account the
- 10 whole picture, from the administration to the school level. As
- 11 any responsible business employs measures to ensure
- 12 accountability and transparency of financial operations, a chief
- 13 financial officer would be the authority on how educational
- 14 dollars are being spent--resources entrusted to them by Hawaii's
- 15 taxpayers. A chief financial officer would greatly strengthen
- 16 the operations of the department of education.
- 17 The purpose of this Act is to strengthen the operations of
- 18 the department of education by creating a chief financial
- 19 officer position and a secretarial position in the office of the
- 20 superintendent.
- 21 SECTION 2. There is appropriated out of the general
- 22 revenues of the State of Hawaii the sum of \$115,000 or so much

- 1 thereof as may be necessary for fiscal year 2006-2007 for the
- 2 establishment of one full-time equivalent (1.00 FTE) permanent
- 3 assistant superintendent position in the department of
- 4 education's office of the superintendent to perform the
- 5 functions of a chief financial officer, including the
- 6 preparation, management, and execution of the department of
- 7 education's financial statements, budgets, accounting, and
- 8 vendor payments.
- 9 SECTION 3. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$43,000 or so much
- 11 thereof as may be necessary for fiscal year 2006-2007 for the
- 12 establishment of one full-time equivalent (1.00 FTE) permanent
- 13 secretary position in the department of education to assist the
- 14 assistant superintendent performing the functions of a chief
- 15 financial officer.
- 16 SECTION 4. The sums appropriated shall be expended by the
- 17 department of education for the purposes of this Act.
- 18 SECTION 5. This Act shall take effect on July 1, 2006.
