# A BILL FOR AN ACT

RELATING TO NON-AGRICULTURAL PARK LANDS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 166E, Hawaii Revised Statutes, is 1 amended by adding six new sections to be appropriately 2 3 designated and to read as follows: "\$166E-A Disposition. (a) Any provision of this chapter 4 to the contrary notwithstanding, the department may dispose of: 5 (1) Public lands and related facilities set aside and 6 designated for use pursuant to this chapter; and 7 (2) Other lands and facilities under the jurisdiction of 8 the department pursuant to section 166E-B and 9 10 notwithstanding chapter 171, by negotiation, drawing of lot, conversion, or public auction. 11 Except as provided by subsection (d), the department shall 12 13 dispose of public lands by lease. (b) In all dispositions, the department shall be subject 14 to the requirements set forth in rules adopted by the board 15 consistent with section 166E-6 and subject to the following: 16

- 1 SECTION 5. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 6. This Act shall take effect upon its approval.
