A BILL FOR AN ACT

RELATING TO ENERGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 Chapter 269, Hawaii Revised Statutes, is SECTION 1. 2 amended by adding four new sections to be appropriately 3 designated and to read as follows: "§269-A Public benefits fund; authorization. (a) 4 The public utilities commission, by order or rule, may redirect all 5 6 or a portion of the funds collected through the current
- 7 demand-side management surcharge by Hawaii's electric utilities
- 8 into a public benefits fund that may be established by the
- 9 public utilities commission.
- 10 If the public utilities commission establishes a
- public benefits fund, the surcharge shall be known as the public 11
- 12 benefits fee. Moneys in the fund shall be ratepayer funds that
- shall be used to support energy-efficiency and demand-side 13
- 14 management programs and services, subject to the review and
- approval of the public utilities commission. These moneys shall 15
- not be available to meet any current or past general obligations 16
- 17 of the State.

- 1 SECTION 7. In codifying the new sections added by section
- 2 1 of this Act, the revisor of statutes shall substitute
- 3 appropriate section numbers for the letters used in designating
- 4 the new sections in this Act.
- 5 SECTION 8. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 9. This Act shall take effect upon its approval.
