A BILL FOR AN ACT

RELATING TO STATE RISK MANAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 41D-4, Hawaii Revised Statutes, is 1 amended by amending subsection (q) to read as follows: 2 3 "(g) Money received from the settlement of claims or 4 losses of the State as delineated in subsection (a) shall be deemed to be trust moneys and may be deposited into the state 5 risk management revolving fund [-] or into a trust account with 6 and under the control of the affected agency at the discretion 7 8 of the comptroller. These moneys and any interest earned thereon shall be used for the purpose identified in any such 9 10 settlement." SECTION 2. Statutory material to be repealed is bracketed 11 12 and stricken. New statutory material is underscored.

SECTION 3. This Act shall take effect on July 1, 2006.
