A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 196, Session Laws of Hawaii 2005, 2 section 38, directed the housing and community development 3 corporation of Hawaii to "prepare an implementation plan for the 4 reorganization of the State's housing functions" including 5 "recommendations for any additional statutory amendments that 6 may be necessary to fully effectuate the implementation plan and 7 the purposes of this Act, and proposed legislation containing 8 the recommended statutory amendments." 9 The purpose of this Act is to effectuate the implementation 10 plan prepared by the housing and community development 11 corporation of Hawaii to create two separate state housing 12 agencies, the Hawaii housing finance and development 13 corporation, and the Hawaii public housing authority, and to 14 make necessary technical and conforming amendments to relevant

statutory provisions.
