# A BILL FOR AN ACT

RELATING TO BUSINESS REGISTRATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 425, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated 2 and to read as follows: 3 Activities not constituting transacting business. 4 "§425-The activities of a foreign general partnership that do not 5 constitute transacting business in this State within the meaning 6 7 of this chapter include: Maintaining, defending, or settling an action or 8 (1)9 proceeding; 10 Holding meetings of its partners or carrying on any (2) other activity concerning its internal affairs; 11 12 (3) Maintaining bank accounts; 13 (4)Maintaining offices or agencies for the transfer, 14 exchange, and registration of the foreign partnership's own securities, or maintaining trustees 15 16 or depositories with respect to those securities; 17 (5) Selling through independent contractors;
