## A BILL FOR AN ACT

RELATING TO CHILDREN.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Senate Concurrent Resolution No. 128, Regular 1 Session 2005, requested the department of public safety and the 2 department of human services to jointly establish a task force 3 to examine issues affecting the children of incarcerated parents 4 and to propose solutions to those issues, as well as methods to 5 break the cycle of crime and violence in these families. 6 Specifically, the task force was requested to: 7 Develop a system to identify children of incarcerated (1)8 parents; 9 Develop programs and support services for these (2)children; 11 Provide support for incarcerated parents, where (3) 12 appropriate; and 13 Develop programs to strengthen these families. 14 (4)During the interim period following the 2005 regular 15 session, the department of public safety and the department of 16 human services established the children of incarcerated parents 17 task force as requested. The task force met three times, but 18
