A BILL FOR AN ACT

MAKES APPROPRIATIONS FOR SCHOOL-BASED SUBSTANCE ABUSE TREATMENT PROGRAMS FOR ADOLESCENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The use of alcohol and other drugs by Hawaii's
- 2 youth can impede social and intellectual development and can
- 3 lead individuals to engage in dangerous activities, such as
- 4 reckless driving, premature and unprotected sex, and violence.
- 5 Substance abuse treatment for students helps stop their use and
- 6 abuse of alcohol and other drugs, reduces criminal behavior,
- 7 increases school attendance, allows them to remain in school
- 8 until graduation, and increases the likelihood of their becoming
- 9 healthy, productive, contributing adults.
- 10 Part of the core continuum of care needed for adolescents
- 11 is early identification followed by early treatment.
- 12 School-based treatment is an effective way to intervene in a
- 13 timely manner and succeed in avoiding more costly treatment,
- 14 avoiding school dropouts, and producing functional adults.
- 15 Adolescent school-based substance abuse treatment programs
- 16 provide services on a scheduled basis on school campuses for
- 17 adolescents with substance abuse problems. Professionally

- 1 directed evaluation, treatment, case management, and recovery
- 2 services are provided to clients with less problematic substance
- 3 abuse-related behavior than would be found in a residential or
- 4 day treatment program. Services are available year-round,
- 5 during the school year, and through the summer months.
- 6 School-based programs also provide outreach to students through
- 7 classroom presentations, networking with teachers and other
- 8 school personnel, and other appropriate methods.
- 9 Adolescent school-based substance abuse treatment programs
- 10 provide:
- 11 (1) Outpatient school-based treatment for a maximum of one
- hundred ninety-two hours per client per year
- consisting of face-to-face individual sessions,
- including screening, assessment, treatment planning,
- and counseling;
- 16 (2) Group sessions, including process, education, skill
- building, and recreation groups; and
- 18 (3) Family counseling.
- 19 Agencies presently contracted by the department of health's
- 20 alcohol and drug abuse division to provide adolescent
- 21 school-based substance abuse treatment services are as follows:
- 22 (1) Hina Mauka on Kauai and Oahu;

The Young Men's Christian Association on Oahu; 1 (2) Aloha House, Inc., and Ohana Makamae, Inc., on Maui; 2 (3) Hale Ho'okupa'a on Molokai; and 3 (4)Big Island Substance Abuse Council on the island of 4 (5) 5 Hawaii. While the department of health provides services that 6 address student alcohol and other drug abuse, programs are not 7 available in all secondary schools. Current resources available 8 for these services provide for programs in all high schools, but 9 not all of the middle and intermediate schools. 10 The purpose of this Act is to appropriate funds to extend 11 adolescent school-based substance abuse treatment programs to 12 all middle and intermediate schools, with priority given to 13 schools with the greatest need. 14 SECTION 2. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$1,817,500 or so much 16
