## A BILL FOR AN ACT

RELATING TO ELECTRONIC COURT RECORDS, DOCUMENTS, PROCESSES, AND CERTIFICATES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 606-3, Hawaii Revised Statutes, is 1 amended to read as follows: 2 "\$606-3 Seal of court[ $_{7}$ ]; physical or electronic seal, 3 signature, or attestation[-] on physical or electronic court 4 records. (a) Each court of record shall have a seal, [the 5 device of] which shall be as approved by the supreme court. The 6 seal shall be in the custody or control of the clerk of the 7 court[\_] and [shall be], when impressed, embossed, stamped, or 8 electronically imprinted upon [all processes and official 9 certificates, a court document, process, or certificate, shall 10 be accompanied by the clerk's official attestation. 11 (b) Any requirement that a court document, process, or 12 certificate shall be signed, certified, acknowledged, verified, 13 exemplified, attested, or made under oath or seal is satisfied 14 if the document bears an electronic seal of the court and an 15 electronic image of the signature or electronic facsimile 16

- perform these acts."
- 3 SECTION 2. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
