## A BILL FOR AN ACT

RELATING TO HISTORIC PRESERVATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	BE II ENACIED BY THE LEGISLATURE OF THE STATE OF HAWAII.			
1	SECTION 1. Recent news articles have brought to the			
2	public's attention the recent use by the boating public of the			
3	small sand bar situated in Kaneohe bay, known to native			
4	Hawaiians as Ahu o Laka. According to recent news articles, the			
5	sand bar is named after an Oahu chief, Laka, who died there.			
6	However, other oral historical sources from native Hawaiians			
7	residing on the windward side of Oahu indicate that the sand bar			
8	is named as an altar to the ancient goddess of hula, Laka. When			
9	the sacred art of hula was banned by western influences, many			
10	followers would practice the art of hula surreptitiously in			
11	hidden and remote places. The sand bar was deemed to be an			
12	excellent locale for this practice since it was remote.			
13	Further, the sand was an excellent medium to dance upon.			
14	Recent news articles described public concerts on the sand			
15	bar which attracted hundreds of persons, resulting in drinking,			
16	littering, and fighting. These reports raise concerns relating			
17	to the desecration of a culturally significant place and the			

degradation of an important aesthetical resource of the state.

1	The purpose of this ACT is to designate Anu O Laka as a		
2	state monument and to adopt rules for the protection and		
3	maintenance of the Ahu o Laka state monument.		
4	SECTION 2. Chapter 6E, Hawaii Revised Statutes, is amended		
5	by adding a new section to part II to be appropriately		
6	designated and to read as follows:		
7	"S6E- Ahu o Laka state monument. (a) There shall be an		
8	Ahu o Laka state monument as a historical, cultural, and		
9	aesthetically valued site at Kaneohe, Oahu, to be administered		
10	by the department of land and natural resources and to consist		
11	<u>of:</u>		
12	(1) The approximately three-acre sand bar in Kaneohe bay,		
13	off Heeia, that is above the water's surface at low		
14	tide; and		
15	(2) The surrounding state marine waters, as that term is		
16	defined in section 190D-3, that the department of land		
17	and natural resources determines is necessary for the		
18	preservation of the historical, cultural, and		
19	aesthetic resources of the Ahu o Laka state monument.		
20	(b) The department of land and natural resources, pursuant		
21	to chapter 91, shall adopt rules for the protection and		

1	maintenan	ce of the Ahu o Laka state monument, to include but not
2	be limited	d to:
3	(1)	Imposing conditions focused on regulating large
4		gatherings at the Ahu o Laka state monument, taking
5		into consideration safety, security, and sanitary
6		concerns; and
7	(2)	Any other rules deemed necessary to protect the
8		aesthetic environment and the cultural sensitivity of
9		the Ahu o Laka state monument."
10	SECT	ION 3. New statutory material is underscored.
11	SECT	ION 4. This Act shall take effect upon its approval.

#### PROCLAMATION

WHEREAS, under Section 16 of Article III of the Constitution of the State of Hawaii, the Governor is required to give notice, by a proclamation, of the Governor's plan to return with the Governor's objections any bill presented to the Governor less than ten days before adjournment sine die or presented to the Governor after adjournment sine die of the Legislature; and

WHEREAS, Senate Bill No. 2004, entitled "A Bill for an Act Relating to Historic Preservation," passed by the Legislature, was presented to the Governor within the aforementioned period; and

WHEREAS, Senate Bill No. 2004 is unacceptable to the Governor of the State of Hawaii;

NOW, THEREFORE, I, LINDA LINGLE, Governor of the State of Hawaii, do hereby issue this proclamation, pursuant to the provisions of Section 16 of Article III of the Constitution of the State of Hawaii, giving notice of my plan to return Senate Bill No. 2004 with my objections thereon to the Legislature as provided by said Section 16 of Article III of the Constitution.

STATEMENT OF OBJECTIONS TO SENATE BILL NO. 2004

Honorable Members Twenty-Third Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, Senate Bill No. 2004, entitled "A Bill for an Act Relating to Historic Preservation."

The purpose of this bill is to designate a sandbar in Kaneohe Bay as the "Ahu o Laka State Monument" and to regulate the use of the sandbar pursuant to rules to be adopted by the Department of Land and Natural Resources.

This bill is objectionable because it provides unnecessary regulation of an active recreational and historical site in Kaneohe Bay. The bill was introduced in response to an incident that occurred in 2005. There exist sufficient laws to govern activities on the sandbar without converting it to State monument status. The Division of Conservation and Resources Enforcement and the United States Coast Guard have the authority to monitor activities that address safety, security, and sanitation concerns.

Secondly, the ability to define the actual State monument area may be difficult, if not impossible, given the shifting sands and movements during tides. Creating a specific perimeter for the State monument might lead to administrative and legal challenges as to where the monument rules do and do not apply.

The cultural and historic nature of the area continue to be researched by the Department of Land and Natural Resources and others. However, long-standing members of the community, locally elected officials, and community leaders stated that there has not been any discussion prior to this bill to suggest

that the sandbar should be treated as a State monument. There is community concern that a monument designation may act to the detriment of the area, encouraging visitor guidebooks, websites, and tourist literature to highlight an area that has traditionally been used by residents and those familiar with the Windward Oahu topography.

For the foregoing reasons, I am returning Senate Bill No. 2004 without my approval.
