A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE DRIVER'S LICENSE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 286-107, Hawaii Revised Statutes, is 1
- amended to read as follows: 2
- "§286-107 License renewals; procedures and requirements. 3
- (a) The examiner of drivers may accept an application for a 4
- renewal of a driver's license made not more than six months 5
- prior to the date of expiration. 6
- If, however, the renewal is not applied for within ninety 7
- days after the expiration of the license, the applicant for 8
- renewal shall be treated as an applicant for a new license and 9
- examined as provided in section 286-108. 10
- Except as otherwise provided in subsection (c), an 11
- applicant for a renewal of a driver's license under this 12
- section, or the reactivation of an expired license under section 13
- 286-107.5(a), shall appear in person before the examiner of 14
- drivers and the examiner of drivers shall administer such 15
- physical examinations as the state director of transportation 16
- deems necessary to determine the applicant's fitness to continue 17
- to operate a motor vehicle. 18

1	(c) Any person who holds a category (1) , (2) , or (3)		
2	license issued under this part who is unable to appear in person		
3	before the examiner of drivers to apply for a renewal of the

6	by mail. The applicant's request to have the license renewed by

14	(e)	No driver's license shall be renewed by the examiner

1	(f) A driver's license renewed pursuant to subsection (c)
2	may validly be issued without incorporating a photograph of the

4	(g) No driver's license shall be renewable by mail for
5	more than two consecutive renewals, regardless of whether the
6	license expires, as provided under section 286-106, on the
7	sixth, fourth, or second birthday after issuance; provided that
8	this subsection shall not apply to a resident military person or
9	that person's immediate family if the resident military person
10	resides outside the [State] state on official military orders.
11	(h) Notwithstanding subsection (a), any applicant for a
12	renewal of a driver's license who is a member of any component
13	of the United States armed forces and who has been ordered to
14	active federal service outside of the state at the time the
15	applicant's license should be renewed shall not have the
16	applicant's license revoked or forfeited for failure to file a
17	timely application for a renewal of a driver's license if the
18	applicant files an application for a renewal of a driver's
19	license, along with verification of federal active service
20	outside the state as required by the examiner of drivers, within
21	ninety days of the applicant's return to the state or discharge

- 2 reactivation fee provided under section 286-107.5.
- 3 [$\frac{(h)}{(h)}$] (i) The state director of transportation shall adopt
- 4 rules and regulations pursuant to chapter 91, necessary for the
- 5 purposes of this section, including rules and regulations
- 6 governing the effect to be given to convictions for violations
- 7 of traffic laws of a foreign jurisdiction, upon license renewal
- 8 procedures."
