- 10 SECTION 5. All unexpended and unencumbered balances of the
- 11 appropriations made in this Act as of the close of business on
- 12 June 30, 2007, shall lapse.
- 13 SECTION 6. If any provision of this Act, or the
- 14 application thereof to any person or circumstance is held
- 15 invalid, the invalidity does not affect other provisions or
- 16 applications of the Act, which can be given effect without the
- 17 invalid provision or application, and to this end the provisions
- 18 of this Act are severable.
- 19 SECTION 7. This Act shall take effect upon its approval.
