## A BILL FOR AN ACT

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 383, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated 2 3 and to read as follows: 4 Distribution of contributions. All 5 contributions pursuant to this chapter shall be deposited as 6 follows: 7 per cent into the unemployment compensation fund; 8 and 9 per cent into the employment and training fund." SECTION 2. Section 383-121, Hawaii Revised Statutes, is 10 amended to read as follows: 11 12 "§383-121 Unemployment compensation fund; establishment 13 and control. There is established in the treasury of the State as a special fund, separate and apart from all public moneys or 14 15 funds of the State, an unemployment compensation fund, which 16 shall be administered by the department of labor and industrial relations exclusively for the purposes of this chapter.
