# A BILL FOR AN ACT

RELATING TO THE HONOPOU DISTRICT OF THE COUNTY OF MAUI.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the safety of
- 2 residents of the Honopou district of the county of Maui may be
- 3 at risk because of the condition of Honopou road, which includes
- 4 Honopou bridge. Residents report that several years ago, a Maui
- 5 county fire department fire truck failed to respond to an
- 6 emergency call for assistance from a Honopou district resident
- 7 because the fire truck crew apparently had concerns about the
- 8 truck's ability to cross the Honopou bridge safely. As a result
- 9 of the Maui county fire department's failure to cross Honopou
- 10 bridge to provide the necessary fire-fighting assistance, the
- 11 home of the Honopou resident burned down.
- 12 Presumably because of Honopou bridge's five-ton rating, the
- 13 fire department feared for the safety of its firefighters in
- 14 crossing the bridge, although residents of the area report that
- 15 fully-loaded cement trucks, weighing approximately thirty-five
- 16 tons, cross Honopou bridge regularly without incident.
- 17 Although Honopou road, a dirt road, runs through state
- 18 land, a jurisdictional dispute exists over ownership of Honopou

- 1 road, which includes the Honopou bridge. Regarding ownership of
- 2 the road, the department of land and natural resources defers to
- 3 the department of transportation, which claims that the road and
- 4 bridge are the responsibility of the county of Maui.
- 5 The legislature further finds that the lack of established
- 6 jurisdictional responsibility has resulted in a corresponding
- 7 lack of maintenance of Honopou road, including Honopou bridge.
- 8 To avoid future threats to the safety and well-being of the
- 9 residents of the Honopou district of the county of Maui, the
- 10 matter of jurisdictional responsibility must be resolved, and
- 11 the Honopou bridge must be strengthened and maintained in a
- 12 manner that allows the Maui county fire department safe access
- 13 across the Honopou bridge to provide necessary public services
- 14 to the residents of the Honopou area.
- The purpose of this Act is to protect the safety and well-
- 16 being of the residents of the Honopou district by:
- 17 (1) Requiring the department of the attorney general to
- assist in resolving the jurisdictional dispute over
- the Honopou road and Honopou bridge; and
- 20 (2) Determining the costs of bringing the Honopou bridge
- up to standards that will allow access to Honopou
- district residents by the Maui county fire department.

SECTION 2. The department of the attorney general shall 1 investigate and assist in the resolution of the issue of 2 ownership of Honopou road, including Honopou bridge, and submit 3 a report of its findings and recommendations, including any 4 legislation deemed necessary to clarify legal jurisdiction, to 5 the legislature no later than twenty days before the convening 6 of the regular session of 2007. 7 The department of transportation shall review 8 SECTION 3. the issues relating to the safety of Honopou bridge and submit a 9 report to the legislature, mayor of Maui, and county council of 10 Maui no later than twenty days before the convening of the 11 regular session of 2007. The report shall include the 12 department's findings and recommendations, including any 13 legislation deemed necessary, that will result in strengthening, 14 repairing, increasing the load limit, and improving Honopou 15 bridge to provide safe access to Honopou district by the Maui 16 county fire department. The department of transportation shall 17 include in its report the estimated cost of improvements to 18 Honopou bridge that are necessary to protect the safety and 19 well-being of residents of the Honopou district. 20 Upon the resolution of the issue of ownership of Honopou 21

- 1 also forward its report to the entity identified with the
- 2 assistance of the attorney general as having jurisdiction over
- 3 Honopou road and Honopou bridge. The department of
- 4 transportation's report of its findings and recommendations
- 5 shall be transmitted to the appropriate government agency no
- 6 less than thirty days after the department's receipt of the
- 7 attorney general's report on the resolution of the
- 8 jurisdictional issue over which public agency has responsibility
- 9 for the Honopou road and Honopou bridge.
- 10 SECTION 4. This Act shall take effect on July 1, 2050.

### Report Title:

Honopou Bridge; Ownership; Firetrucks

#### Description:

Requires the attorney general to assist in resolving ownership issues relating to Honopou road, including Honopou bridge, of the Honopou district in Maui County; requires the department of transportation to determine the costs of strengthening Honopou bridge to allow firetrucks to safely cross and reach area residents.
