A BILL FOR AN ACT

RELATING TO ENERGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In May 2002, the University of Hawaii gathered
2	major energy and policy stakeholders in Hawaii to convene as the
3	Hawaii energy policy forum (policy forum). The purpose of the
4	policy forum was to develop an energy vision for Hawaii through
5	the year 2030 and to formulate strategies consistent with
6	implementing that vision. Accordingly, facilitated discussions
7	were conducted on Hawaii's preferred energy future and the
8	issues and constraints that would be encountered in achieving
9	that preferred future. Incorporating a science- and fact-based
10	approach, policy studies were conducted to provide baseline
11	information and review of various environmental, regulatory,
12	economic, social, and cultural issues relating to Hawaii's
13	energy future.
14	In December 2003, the policy forum convened a policy summit
15	to provide a community-based forum for review of its work and
16	recommendations. The final report of the policy forum, "Hawaii
17	at the Crossroads: A Long Term Energy Strategy," sets forth

1 recommended guiding principles and policy options to meet 2 Hawaii's long term energy needs. 3 The purpose of this Act is to appropriate funds to 4 reconvene the policy forum for the purpose of implementing the 5 vision, concepts, and recommendations of the policy forum's 6 final report, and the resulting "Ten Point Plan" to meet 7 Hawaii's energy goals. This will provide a unique opportunity 8 for stakeholders to continue their work from planning to 9 implementation and for further engagement of policy and **10** decision-makers and consumers on issues relevant to creating 11 Hawaii's preferred energy future. **12** SECTION 2. There is appropriated out of the general **13** revenues of the State of Hawaii the sum of \$200,000 or so much 14 thereof as may be necessary for fiscal year 2006-2007 to 15 reconvene the Hawaii energy policy forum for the purpose of: 16 (1)Developing a detailed action plan and timeline to 17 implement the recommendations of the Hawaii energy 18 policy forum's "Ten Point Plan" to meet Hawaii's 19 energy goals;

Developing tangible goals, objectives, desired

and strategy of the Hawaii energy policy forum;

outcomes, and actions to implement the energy vision

14	The	sum appropriated shall be expended by the department of
15	business,	economic development, and tourism for the purposes of
16	this Act.	
17	SECT	ION 3. The Hawaii energy policy forum shall submit a
18	report on	the detailed action plan and timeline to the
19	legislatu	re no later than twenty days prior to the convening of
20	the regul	ar session of 2007.
21	SECT	ION 4. This Act shall take effect on July 1, 2006.
