A BILL FOR AN ACT

RELATING TO LONG TERM CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The executive office on aging's long-term care
2	ombudsman program is mandated by the U.S. Administration on
3	Aging through the Older Americans Act. The program provides
4	ombudsmen to advocate for and protect the rights of residents of
5	nursing homes, adult residential care homes, expanded adult
6	residential care homes, and assisted living facilities. The
7	long-term care ombudsman program staff investigate and expedite
8	resolution of residents' complaints statewide, on a confidential
9	basis.
10	The long-term care ombudsman program also provides:
11	(1) Information and referral assistance;
12	(2) Conducts educational activities to increase community
13	awareness of elder rights, advocates at the
14	legislature; and
15	(3) Provides training to long-term care staff, family
16	councils, and resident councils.
17	The program currently is staffed by two qualified ombudsman
18	specialists who are charged with assuring advocacy and patient

- 1 rights protection for an estimated eight thousand residents of
- 2 the seven hundred thirty-one licensed facilities in Hawaii. In
- 3 recent years, appropriations for the recruiting, training, and
- 4 retaining of volunteers to augment the ombudsman staff to assure
- 5 program services to the neighbor islands have proved inadequate.
- 6 Moreover, the volunteer program has not been a feasible solution
- 7 to address the needs of all licensed facility residents, many of
- 8 whom do not have family members to assure their quality of care
- 9 in an institutional setting.
- 10 The purpose of this Act is to appropriate funds to the
- 11 executive office of aging for the operation and delivery of the
- 12 long-term care ombudsman program on the neighbor islands, and
- 13 for operating costs to support the neighbor island long-term
- 14 care ombudsman and volunteer programs.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$1 or so much thereof
- 17 as may be necessary for fiscal year 2006-2007 for the executive
- 18 office on aging for the operation and delivery of the long-term
- 19 care ombudsman program on the neighbor islands.
- The sum appropriated shall be expended by the department of
- 21 health for the purposes of this section.

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$1 or so much thereof
- 3 as may be necessary for fiscal year 2006-2007 for the
- 4 recruitment, training, and sustaining of volunteers to augment
- 5 the long-term care ombudsman program staff and for operating
- $\mathbf{6}$ costs of the neighbor island long term care ombudsman program
- 7 staff.
- 8 The sum appropriated shall be expended by the department of
- 9 health for the purposes of this section.
- 10 SECTION 4. This Act shall take effect on July 1, 2006.
