# A BILL FOR AN ACT

RELATING TO TECHNOLOGY TRAINING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the expanding
- 2 technical components of Hawaii's New Economy--dual-use
- 3 opportunities, digital media, life and health sciences,
- 4 agribusiness, and natural sciences--demands a highly trained and
- 5 skilled workforce to be developed in a phased-in approach over
- 6 the next ten years.
- 7 The purpose of this Act is to work within the broad
- 8 partnerships that the department of labor and industrial
- 9 relations, the workforce development council, and the county-
- 10 level workforce investment boards are presently developing.
- 11 Specifically, this Act would support partnership workforce
- 12 development and outreach considerations, which address state
- 13 business, education, and labor goals.
- 14 Partnerships efforts will complement and expand existing
- 15 programs on the neighbor islands such as Project EAST
- 16 (Environment and Spatial Technology), Women in Technology,
- 17 Kauai's Aloha 'Ike programs, North Kohala's Community Resource
- 18 Center, and other similar projects between schools and



- 1 businesses in the state. These programs operate successfully on
- 2 the neighbor islands and serve as models for local and regional
- 3 development. Developing comparable programs on Oahu will create
- 4 an educational pipeline to the University of Hawaii and the
- 5 community colleges statewide.
- 6 Partnership efforts will also focus on creating excitement
- 7 for new business development and careers in science and
- 8 technology through collaborative marketing, exhibition,
- 9 communication efforts with the Bishop Museum Science Center,
- 10 'Imiloa Astronomy Center in Hilo, Gateway Center at NELHA, the
- 11 Maui Food Technology Institute, and Kauai Technology Center.
- 12 Corporate sponsorships, such as the Hawaiian Tel internship
- 13 program, will encourage the development of a sustainable trained
- 14 local workforce through mentoring, apprenticeships, and the
- 15 "Kama'aina Come Home" campaign.
- 16 Capitalizing on existing private sector partnerships will
- 17 enhance outreach to technology-based foundations and
- 18 philanthropists, encourage entrepreneurship, and build new
- 19 incentives for food, fuel, and technology sustainability for
- 20 generations to come.

## H.B. NO. H.D.

The purpose of this Act is to appropriate funds to the 1 Economic Development Alliance of Hawaii, Inc., for the purpose 2 of improving and expanding our technology workforce. 3 SECTION 2. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$ or so 5 much thereof as may be necessary for fiscal year 2006-2007 as a 6 grant to the Economic Development Alliance of Hawaii, Inc., 7 pursuant to chapter 42F, Hawaii Revised Statutes, to expand 8 technology training opportunities statewide; provided that no 9 funds shall be expended unless matching funds are provided and 10 resulting projects are consistent with the state plan for 11 workforce development prepared by the workforce development 12 council. 13 The sum appropriated shall be expended by the department of 14 labor and industrial relations for the purposes of this Act. 15 SECTION 3. This Act shall take effect on July 1, 2006. 16
