A BILL FOR AN ACT

RELATING TO SUBSTANCE ABUSE TREATMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that, whether it is
2	called "ice", "batu", or "shabu", crystal methamphetamine has
3	been a serious public health issue in Hawaii since the late
4	1980s. Accessible and highly addictive, "ice" usage has reached
5	epidemic proportions and has affected all of Hawaii's ethnic,
6	socioeconomic, and geographic sectors. There have been several
7	recent and sensational incidents involving its use including one
8	long term, mentally ill drug user who axed his elderly father to
9	death and seriously injured his mother because they refused to
10	give him money to buy "ice". Another recent incident involved a
11	spectacular hit and run crash in east Honolulu that involved
12	over a dozen vehicles and tied up traffic for hours. A stolen
13	vehicle whose occupants were known "ice" users caused the crash.
14	The legislature also finds that Hawaii's community
15	coalitions play an important role in bringing residents, service
16	providers, and other community members together to focus on the
17	"ice" issue in local neighborhoods and communities. It is vital
18	to keep existing community coalitions viable and mobilized and

1	encourage the development of new or emerging community			
2	coalitions. This approach will empower community coalitions to			
3	assist in the prioritization of resources and funding through			
4	cooperative problem solving, planning, and bottom-up decision-			
5	making.			
6	The purpose of this Act is to fund geographical areas			
7	identified by school complexes statewide through existing or			
8	emerging community coalitions to coordinate local anti-drug			
9	community efforts, fill service gaps, and implement best			
10	practice prevention programs.			
11	SECTION 2. There is appropriated out of the general			
12	revenues of the State of Hawaii the sum of \$14,700,000 or so			
13	much thereof as may be necessary for fiscal year 2006-2007 for			
14	existing or emerging community coalitions in all forty-two			
15	school complexes used as geographical identifiers of areas to			
16	receive funding statewide to coordinate local anti-drug			
17	community efforts, fill service gaps, and implement best			
18	practice prevention programs as follows:			
19	(1) Youth substance abuse prevention and			
20	intervention programs: \$5,250,000			
21	To provide effective, best practice, and			
22	culturally adapted drug prevention and			

1		intervention and education programs for	
2		youth. These programs may include a wide	
3		range of youth-focused activities such as:	
4		mentoring, after school tutoring and	
5		recreational activities, culturally-based	
6		dance and performance activities, sports,	
7		and martial arts programs. They may also
