## A BILL FOR AN ACT

RELATING TO HIV/AIDS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:

6	§ -1 Purpose. Recognizing the magnitude of the many
· 7	problems and issues related to HIV/AIDS in Hawaii, including
8	prevention, housing, food, drugs, insurance, primary medical and
9	dental care, social services, need for coordination, and
10	development of public and private policies. The purpose of this
11	chapter is to establish a statewide commission to promote and
12	develop comprehensive planning and policymaking to address
13	current and emerging issues relating to HIV/AIDS. The intent of
14	the legislature is to provide a comprehensive statewide planning
15	and policymaking process that:
16	(1) Promotes review and integration of local, regional,
17	and national HIV/AIDS planning activities; and

1	(2)	Provides a comprehensive blueprint for the ongoing
2		understanding of HIV/AIDS and coordination between
3		private and public agencies, programs, and resources.

(a) The commission shall make biennial policy **16** 17 recommendations that shall: 18 (1)Take into account and shall seek to harmonize: 19 Roles, functions, plans, and needs of government (A) 20 agencies and private entities statewide;

Reviews and recommendations regarding resources;

1 Changing health, social, legal, political, and (C) 2 economic implications and impacts; 3 and 4 (2) Provide directed dialog and advocacy in support of 5 defined policy recommendations. 6 The commission shall reflect a balance of the need for multi-7 discipline approaches and understanding of comprehensive 8 community-based planning for the complex issues related to the 9 health, social, legal, political, and economic elements of 10 HIV/AIDS and public well-being and quality of life. 11 (b) The commission policy recommendations shall consider: **12** Strategies and policies that maximize coordination and (1)13 use of resources; 14 Strategies that conserve limited resources; and (2) 15 (3) The need for development of additional or changing 16 resources to address issues and concerns. 17 The commission's policy recommendations shall be **18** projected at least five years into the future. 19 -5 Staffing. The commission shall hire an executive 20 director to conduct and coordinate the duties of the commission. 21 The executive director may hire a project specialist and other

staff as necessary."

- 1 SECTION 2. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$1 or so much thereof
- 3 as may be necessary for fiscal year 2006-2007 for the Hawaii
- 4 state commission on HIV/AIDS.
- 5 The sum appropriated shall be expended by the
- 6 for the purposes of this Act.
- 7 SECTION 3. This Act shall take effect upon its approval,
- 8 except that section 2 shall take effect on July 1, 2006.
