A BILL FOR AN ACT

RELATING TO OUT-OF-STATE SALES OF TIME SHARE INTERESTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 514E-30, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§514E-30 Scope of chapter. This chapter applies to the
4	offer and sale in Hawaii of time share interests in time share
5	units located in Hawaii. If time share units are located
6	outside of Hawaii, but any offer or sale is made within the
7	State, this chapter, except for sections 514E-3, 514E-4, 514E-5,
8	514E-6, 514E-7, and 514E-14, shall apply. As to the offer and
9	sale outside of Hawaii of time share [interest] interests in a
10	time share plan [which] that includes time share units located
11	in Hawaii, this chapter, except for sections 514E-2.5, 514E-8,
12	514E-9, 514E-10(b) and (c), 514E-11, and 514E-11.1 shall apply.
13	Notwithstanding the foregoing, with respect to a time share
14	plan containing accommodations or facilities located in Hawaii
15	which is offered for sale outside the jurisdictional limits of
16	the United States, such offer or sale shall be exempt from the
17	requirements of this chapter; provided that the developer shall
18	either file the time share plan with the director for approval

1	pursuant	to this chapter or pay an exemption registration fee of
2	\$100 and	file the following minimum information pertaining to
3	the time	share plan with the director for approval:
4	(1)	The name and address of the time share plan;
5	(2)	The name and address of the developer and seller, if
6		any;
7	(3)	The location and a brief description of the
8		accommodations and facilities, if any, that are
9		<pre>located in Hawaii;</pre>
10	(4)	The number of time share interests and duration to be
11		offered;
12	(5)	The term of the time share plan;
13	(6)	A copy of the time share instrument relating to the
14		management and operation of accommodations and
15		facilities, if any, that are located in Hawaii;
16	(7)	A copy of the budget required by section 514E-9;
17	(8)	A copy of the management agreement and any other
18		contracts regarding management or operation of the
19		accommodations and facilities, if any, that are
20		located in Hawaii, and which have terms in excess of
21		one year; and

1	(9)	A copy of the provision of the contract to purchase an
2		interest in a time share plan to be utilized in
3		offering the time share plan containing the following
4		disclosure in conspicuous type immediately above the
5		space provided for the purchaser's signature:
6		'The offering of this time share plan outside the
7		jurisdictional limits of the United State of America
8		is exempt from regulation under Hawaii law, and any
9		such purchase is not protected by the laws of the
10		State of Hawaii. The management and operation of any
11		accommodations or facilities located in Hawaii,
12		however, is subject to Hawaii law and may give rise to
13		an enforcement action regardless of where the offer
14		was made."
15	SECT	ION 2. Statutory material to be repealed is bracketed
16	and stric	ken. New statutory material is underscored.
17	SECT	ION 3. This Act shall take effect upon its approval.
