A BILL FOR AN ACT

RELATING TO IDENTITY THEFT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In 2005, the Hawaii anti-phishing task force		
2	was established in the department of the attorney general to		
3	develop state policy on how best to prevent further occurrences		
4	of phishing and other forms of electronic commerce-based crimes		
5	in the state. The task force focused on:		
6	(1) Examining state agencies charged with the		
7	responsibility of developing policies, procedures, and		
8	operations to prevent, monitor, and enforce electronic		
9	commerce-based criminal activities and sanctions;		
10	(2) Deriving best practice models from the review of other		
11	jurisdictions' activities, policies, and laws related		
12	to the prevention of electronic commerce-based crimes;		
13	(3) Exploring other options available to the task force to		
14	deter electronic commerce-based crimes from occurring		
15	in the state; and		
16	(4) Establishing findings and recommendations on		
17	electronic commerce-based crime prevention.

The task force submitted to the legislature findings and 1 recommendations on deterring electronic commerce-based crime. 2 The purpose of this Act is to implement the task force 3 recommendations. 4 SECTION 2. Act 65, Session Laws of Hawaii 2005, is amended 5 by amending section 2 to read as follows: 6 "SECTION 2. (a) There is established [within the 7 department of the attorney general] a [Hawaii anti-phishing] 8 joint legislative identity theft task force to examine options 9 to prevent electronic commerce-based crimes in the [State.] 10 state and to safeguard and protect from identity theft all 11 personal identifying information collected by the State. 12 The [Hawaii anti-phishing] joint legislative identity 13 theft task force shall include members as follows: 14 The attorney general or the attorney general's 15 (1)designee; 16 The director of the office of consumer protection; (2)17 The United States Attorney for the District of Hawaii 18 (3)or the United States Attorney's designee; 19 Two members [of the Hawaii state senate] to be 20 (4)appointed by the president of the senate; 21

2		representatives to be appointed by the speaker of the

4	(6)	Two members representing the financial services
5		industry, one appointed by the president of the senate

8	(7)	A member of the Honolulu police department's criminal
9		investigation division; [and]
10	(8)	A member of the Honolulu field office's United States
11		Secret Service electronic crimes unit [-];
12	(9)	The chief justice of the supreme court or the chief
13		justice's designee;
14	(10)	A member representing all of the county police
15		departments appointed by the police chiefs;
16	(11)	A member from the Hawaii Prosecuting Attorneys'
17		Association;
18	(12)	A member representing the United States Postal
19		Service;
20	(13)	A member representing the Chamber of Commerce of
21		Hawaii;

1	(14)	A member representing the Consumer Data Industry
2		Association; and
3	(15)	A member representing the National Federation of
4		Independent Business.
5	(C)	The task force shall:
6	(1)	Examine the policies, procedures, and operations of
7		state agencies charged with the responsibility of
8		developing policies to prevent electronic commerce-
9		based crimes, monitoring electronic commerce-based
10		criminal activity, and enforcing electronic
11		commerce-based criminal sanctions;
12	(2)	Review other jurisdictions' activities, policies,
13		directives, and laws related to preventing electronic
14		commerce-based crimes and derive best practices models
15		therefrom;
16	(3)	Explore any other options available to the task force
17		to deter electronic commerce-based crimes from
18		occurring in the State; [and]
19	(4)	Establish findings and develop recommendations on how
20		the State may best deter electronic commerce-based
21		crimes from occurring in the [State.]; and

1	(5) Identify best practices to prevent identity theft by		
2	reviewing other jurisdictions' activities, policies,		
3	and laws related to protecting personal identifying		
4	information collected by the State, and establish a		
5	timetable for the immediate removal of personal		
6	identifying information from public records.		
7	(d) The members of the task force shall select the		
8	chairperson of the task force and shall be reimbursed for		
9	expenses, including travel expenses, necessary for the		
10	performance of their duties.		
11	$\left[\frac{\text{(d)}}{\text{(e)}}\right]$ The task force shall submit its findings and		
12	recommendations to the legislature, including any proposed		
13	legislation, no later than twenty days prior to the convening o		
14	the [2006] <u>2007</u> regular session.		
15	[(e)] <u>(f)</u> The [department of the attorney general]		
16	legislative reference bureau shall provide the research and		
17	organizational support services necessary to assist the task		
18	force in achieving its purpose as required under this Act.		
19	$\left[\frac{f}{f}\right]$ (g) The task force shall cease to exist on June 30,		
20	[2006] <u>2007</u> ."		
21	SECTION 3. There is appropriated out of the general		
22	revenues of the State of Hawaii the sum of \$ or so		

- 1 much thereof as may be necessary for fiscal year 2006-2007 for
- 2 reimbursement of travel expenses of task force members.
- 3 The sum appropriated shall be expended by the legislature
- 4 for the purposes of this Act.
- 5 SECTION 4. All appropriations, records, equipment,
- 6 machines, files, supplies, contracts, books, papers, documents,
- 7 maps, and other personal property heretofore made, used,
- 8 acquired, or held by the department of the attorney general
- 9 relating to the functions transferred to the legislature shall
- 10 be transferred with the functions to which they relate.
- 11 SECTION 5. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 6. This Act shall take effect on July 1, 2096.
