## A BILL FOR AN ACT

RELATING TO HUMAN SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

(a) The commission shall define the executive director's powers and 5 duties and fix the executive director's compensation. 6 The executive director and any staff shall be entitled to 7 8 participate in any public employee benefit plan. (b) In addition to the duties established by the 9 commission, the duties of the executive director shall include 10 11 but not be limited to: Assisting in the development of policies and 12 (1)directives to ensure the well being of at-risk and 13 incarcerated youth and to preserve the civil rights of 14 15 at-risk and incarcerated youth; (2) Obtaining and providing information on national and 16 local standard practices and best practices, as well 17 18 as the spectrum of services provided by the Hawaii 19 youth correctional facility and the office of youth

(a) [This 4 chapter creates] There is established within the department of 5 human services for administrative purposes only[, and to be 6 placed within the office of youth services under the supervision 7 of the director and such other subordinates as the director 8 shall designate, ] the Hawaii youth correctional facilities.  $[\frac{b}{c}]$  (c) The policy and purpose of this chapter is to 1 harmonize the sometimes conflicting requirements of public 2 safety, secure placement, and individualized services for law 3 4 violators in the custody and care of the [director.] 5 administrator. To that end, the [director] administrator shall [provide the opportunity for intelligence and aptitude 6 7 evaluation, psychological testing and counseling, prevocational 8 and vocational training, and employment counseling to ensure 9 that the youth correctional facilities and other needed 10 correctional services meet the present needs of all persons 11 committed to the Hawaii youth correctional facilities. 12 [Counseling services shall be available to the committed 13 person's family during the term of commitment.
