A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that with the enactment			
2	of Act 2, Session Laws of Hawaii 2002, two existing public			
3	schools in high-need communities have converted to new century			
4	conversion charter schools. The transitions of these schools to			
5	new century conversion charter schools have brought additional			
6	financial resources, increased accountability, and improved			
7	student achievement. It has increased community and family			
8	involvement in school community activities to promote student			
9	learning.			
10	As the legislature increases its financial support to our			
11	educational system, nonprofit organizations for the new century			
12	conversion charter schools will be faced with a greater burden			
13	to match a minimum contribution of \$1 per pupil toward the			
14	operation of the new century conversion charter school for every			
15	\$4 per pupil allocated by the department of education. It is			
16	not the intent of the legislature to discourage nonprofit			

organizations from supporting our educational system with

additional financial resources.

1	The minimum contribution of nonprofit organizations will		
2	create a greater burden to them as the legislature increases it		
3	support of our educational system. Because of this, nonprofit		
4	organizations may be reluctant to support the creation of		
5	additional new century conversion charter schools without		
6	knowing what financial burdens they will face as the legislatur		
7	increases its funding level.		
8	The purpose of this Act is to set forth a financial limit		
9	on the total maximum contribution per pupil that a nonprofit		
10	organization will be required to contribute in advance, should		
11	the nonprofit organization decide to undertake the creation of		
12	new century conversion charter school.		
13	SECTION 2. Section 302A-1191, Hawaii Revised Statutes, is		
14	amended by amending subsection (a) to read as follows:		
15	"(a) As used in this section:		
16	"New century conversion charter school" means:		
17	(1) Any existing department school that converts to a		
18	charter school and is managed and operated in		
19	accordance with subsection (d); or		
20	(2) Any existing department school that converts to a		
21	charter school and is managed and operated by a		

1		nonprofit organization in accordance with this
2		section, excluding subsection (d).
3	"Non	profit organization" means a private, nonprofit, tax-
4	exempt en	tity that:
5	(1)	Is recognized as a tax-exempt organization under
6		section 501(c)(3) of the Internal Revenue Code of
7		1986, as amended;
8	(2)	Is domiciled in this State; and
9	(3)	Makes a minimum annual contribution of \$1 per pupil
10		toward the operation of a new century conversion
11		charter school for every \$4 per pupil allocated by the
12		charter school administrative office for the operation
13		of the charter school[-]; provided that a nonprofit
14		organization shall not be required to contribute more
15		than the total required contribution per pupil per
16		year.
17	"Tot	al required contribution" means:
18	(1)	\$1,500 for school years 2006-2007 through 2010-11;
19	(2)	\$1,650 for school years 2011-2012 through 2015-2016;
20		<u>and</u>
21	(3)	\$1,815 for school years 2016-2017 through 2020-2021.
