A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the closure of Del
2	Monte Fresh Produce will have a significantly adverse effect on
3	pineapple workers. Housing ranks among their primary concerns.
4	Currently, many employees, retirees, and their families live in
5	plantation homes owned by the company at the Kunia and Poamoho
6	camps. With the closure of Del Monte Fresh Produce, many of
7	these families face the possibility of losing their homes.
8	Housing is a fundamental need, to which every person should have
9	access.
10	With the loss of their jobs, many employees and retirees
11	will undergo a transition period as they seek new employment,
12	participate in job training programs, or seek other
13	opportunities. While employee incomes may be greatly
14	diminished, employees and retirees must continue to make their
15	housing payments and meet other living expenses. Many former

employees and retirees in transition may find it difficult to

qualify for loans under conventional loan-writing standards.

1	The purpose of this Act is to assist Kunia and Poamoho						
2	pineapple workers and retirees in danger of losing their homes						
3	by:						
4	(1) Establishing a program of low-interest loans and						
5	grants for home acquisition and rehabilitation;						
6	(2) Establishing a rental assistance program for rental of						
7	safe, decent, and sanitary units in the private						
8	market; and						
9	(3) Providing supportive services to prepare current						
10	renters for homeownership.						
11	PART I						
12	SECTION 2. Chapter 201H, Hawaii Revised Statutes, is						
13	amended by adding a new section to be appropriately designated						
14	and to read as follows:						
15	"S201H-A Kunia-Poamoho housing revolving fund;						
16	established. (a) There is established in the state treasury						
17	the Kunia-Poamoho housing revolving fund to provide low-interest						
18	loans or grants for the acquisition, rehabilitation, or						
19	reconstruction of existing homes in the Kunia and Poamoho camps						
20	by pineapple workers and retirees who are displaced by the						
21	closure of Del Monte Fresh Produce and who have been denied						
22	loans from traditional financial institutions. The Kunia-						

1	Poamoho housing revolving fund shall be administered by the
2	administration.
3	(b) Low-interest loans may be made to nonprofit
4	organizations that assist pineapple workers or retirees
5	displaced by the closure of Del Monte Fresh Produce.
6	(c) The rate of interest on loans executed pursuant to
7	this section shall not exceed three per cent per year. Interest
8	earnings on loans made pursuant to this section may be used for
9	administrative and other expenses necessary for administering
10	the loan program. Guidelines shall be established by the
11	administration with respect to loan terms and loan qualification
12	criteria. Moneys appropriated for the purposes of this section
13	shall be deposited into the Kunia-Poamoho housing revolving
14	fund; provided that upon fulfillment of the purposes of this
15	section, all unencumbered moneys shall lapse into the general
16	fund.
17	(d) The administration shall adopt rules in accordance
18	with chapter 91 to effectuate the purposes of this section."
19	SECTION 3. There is appropriated out of the general
20	revenues of the State of Hawaii the sum of \$ or so
21	much thereof as may be necessary for fiscal year 2006-2007 for
22	deposit into the Kunia-Poamoho housing revolving fund

- 2 provide low-interest loans or grants for the acquisition,
- 3 rehabilitation, or reconstruction of homes in the Kunia and
- 4 Poamoho camps for pineapple workers or retirees displaced by the

- 6 activities.
- 7 The sum appropriated shall be expended by the Hawaii
- 8 housing finance and development administration for the purposes
- 9 of this part.

- 11 SECTION 4. Chapter 201H, Hawaii Revised Statutes, is
- 12 amended by adding a new section to be appropriately designated
- 13 and to read as follows:
- 14 "\$201H-B Kunia-Poamoho rental housing fund; established.
- 15 (a) There is established in the state treasury the Kunia-
- 16 Poamoho rental housing fund to make annual payments to a
- 17 landlord to provide rent subsidies for eligible Del Monte Fresh
- 18 Produce pineapple workers and retirees and their families who
- 19 are displaced by the closure of Del Monte Fresh Produce and are
- 20 seeking safe, decent, and sanitary housing in the private
- 21 market. The Kunia-Poamoho rental housing fund shall be
- 22 administered by the administration.

1	(b) Moneys appropriated for the purposes of this section							
2	shall be deposited into the Kunia-Poamoho rental housing fund;							
3	provided that upon fulfillment of the purposes of this section,							
4	all unencumbered moneys shall lapse into the general fund.							
5	Guidelines shall be established by the administration with							
6	respect to eligible Del Monte Fresh Produce pineapple workers							
7	and retirees and rental assistance payments under this section.							
8	(c) The administration shall adopt rules in accordance							
9	with chapter 91 to effectuate the purposes of this section."							
10	SECTION 5. There is appropriated out of the general							
11	revenues of the State of Hawaii the sum of \$ or so							
12	much thereof as may be necessary for fiscal year 2006-2007 for							
13	deposit into the Kunia-Poamoho rental housing fund established							
14	under section 201H-B, Hawaii Revised Statutes, to provide rent							
15	subsidies for eligible Del Monte Fresh Produce pineapple workers							
16	and retirees and their families who are displaced by the closure							
17	of Del Monte Fresh Produce and are seeking safe, decent, and							
18	sanitary housing in the private market.							
19	The sum appropriated shall be expended by the Hawaii							
20	housing finance and development administration for the purposes							
21	of this part.							

1	PART III
2	SECTION 6. Chapter 201H, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	"S201H-C Kunia-Poamoho homeownership counseling program;
6	established. (a) There is established within the
7	administration the Kunia-Poamoho homeownership counseling
8	program to provide pineapple workers and retirees who are
9	displaced by the closure of Del Monte Fresh Produce with
10	homebuyer education and counseling.
11	(b) The administration may secure the services of a public
12	or private entity to carry out the purposes of this section."
13	SECTION 7. There is appropriated out of the general
14	revenues of the State of Hawaii the sum of \$ or so
15	much thereof as may be necessary for fiscal year 2006-2007 to
16	effectuate the Kunia-Poamoho homeownership counseling program
17	established under section 201H-C, Hawaii Revised Statutes.
18	The sum appropriated shall be expended by the Hawaii
19	housing finance and development administration for the purposes
20	of this part.
