A BILL FOR AN ACT

RELATING TO PUBLIC ASSISTANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that as the cost of 2 living increases each year, the standard of need in Hawaii,
- 3 which is based on the federal poverty level for the State, is
- 4 not adjusted to reflect this increase and is still based on the
- 5 federal poverty level in 1993. The legislature further finds
- 6 that the medically needy income standard is based on the
- 7 standard of need for the State and is adjusted when the standard
- 8 of need payment is changed.
- 9 The purpose of this Act is to adjust the State's standard
- 10 of need by updating it to reflect the current federal poverty
- 11 level for Hawaii. The legislature's intent is also to adjust
- 12 the medically needy income standard to reflect the annual
- 13 standard of need for the State.
- 14 SECTION 2. Section 346-53, Hawaii Revised Statutes, is
- 15 amended by amending subsections (a) and (b) to read as follows:
- "(a) This subsection [does not] shall apply to general
- 17 assistance to households [without] with minor dependents[-] and
- 18 includes the aged, blind, and disabled. The standard of need



1	for ramiffles of given sizes shall equalper cent of the
2	current poverty level established by the federal government [in
3	1993,] prorated over a twelve-month period.
4	The assistance allowance provided shall be based on a
5	percentage of the standard of need. For exempt households and
6	households in which all caretaker relatives are minors, living
7	independently with minor dependents and attending school, the
8	assistance allowance shall be set at sixty-two and one-half per
9	cent of the standard of need. For all other households, the
10	assistance allowance shall be set no higher than sixty-two and
11	one-half per cent of the standard of need and set no lower than
12	fifty per cent of the standard of need. The standard of need
13	shall be determined by dividing per cent of the [1993]
14	current federal poverty level by twelve and rounding down the
15	quotient. The remaining quotient shall be multiplied by the per
16	cent as set by the director by rules pursuant to chapter 91, and
17	the final product shall be rounded down to determine the
18	assistance allowance; provided that:
19	(1) The department may increase or reduce the assistance
20	allowance as determined in this subsection for
21	non-exempt households for the purpose of providing

3	(2)	No reduction shall be allowed that jeopardizes	
4		eligibility for or receipt of federal funds;	
5	(3)	Reductions in the assistance allowance shall be	
6		limited to no more than one per year; and	
7	(4)	No non-exempt household, which includes an adult who	
8		has received sixty cumulative months of temporary	
. 9		assistance to needy families with minor dependents,	
10		shall be eligible for an assistance allowance, unless	
11		authorized by federal regulations.	
12	(b)	The director shall determine the allowance for general	
13	assistance	to households without minor dependents based upon the	
14	[total amo	ount appropriated for general assistance to households	
15	without mi	nor dependents, standard of need, among other	
16	relevant factors."		
17	SECTI	ON 3. Section 346-71, Hawaii Revised Statutes, is	
18	amended by	amending subsection (e) to read as follows:	
19	"(e)	Within the limitations of this section, the	
20	department	shall, by rules adopted pursuant to chapter 91,	
21	determine:

2		without minor dependents based upon the [total amount
