## A BILL FOR AN ACT

RELATING TO STATE FUNDS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, whether it is 2 called "ice," "batu," or "shabu," crystal methamphetamine has 3 been a serious public health issue in Hawaii since the late 4 1980s. Accessible and highly addictive, "ice" usage has reached 5 epidemic proportions and has affected all of Hawaii's ethnic, 6 socioeconomic, and geographic sectors. There have been several 7 recent and sensational incidents involving its use, including 8 one long-term mentally ill drug user who axed his elderly father 9 to death and seriously injured his mother because they refused 10 to give him money to buy "ice." Another incident includes the 11 spectacular hit and run crash in east Honolulu that involved 12 over a dozen vehicles and tied up traffic for hours. The crash 13 was caused by occupants of a stolen vehicle who were known "ice" 14 users. 15 The legislature further finds that Hawaii's community 16 coalitions play an important role in bringing residents, service **17** providers, and other community members together to focus on the

"ice" issue in local neighborhoods and communities. It is vital

1 to keep existing community coalitions viable and mobilized, and 2 to encourage the development of new or emerging community 3 coalitions. This approach will empower community coalitions to assist in the prioritization of resources and funding through 4 5 cooperative problem solving, planning, and bottom-up decision-making. One way to maintain this approach is for the 6 department of health's alcohol and drug abuse division to 7 8 administer a program to award grants to community coalitions who 9 are using evidence-based models or best practices to provide prevention services specifically in areas that do not have 10 11 existing resources. The legislature notes that efficient resource management is a key ingredient in programmatic success, 12 13 and the department of health shall be called upon to report to 14 the legislature on its use of state-allocated funds. 15 The legislature further finds that the use of alcohol and **16** other drugs by our youth can impede social and intellectual 17 development and can lead individuals to engage in dangerous 18 activities, such as reckless driving, premature and unprotected 19 sex, and violence. Part of the core continuum of care needed for adolescents is early identification of any substance abuse 20 21 issues, followed by early treatment. School-based treatment is

an effective way to intervene timely in an adolescent's life,

- 1 and succeed in avoiding more costly treatment later, producing a 2 lower dropout rate, and increasing adult functionality. While 3 the department of health provides services that address student alcohol and other substance abuse, programs must be available in 4 all middle and intermediate schools. 5 6 The purpose of this Act is to appropriate moneys to fund a 7 grant program for community coalitions to implement best 8 practices in local substance abuse prevention efforts; to fund 9 the administration and coordination of grant program resources 10 through the alcohol and drug abuse division of the department of 11 health; and to extend adolescent school-based substance abuse 12 treatment programs to middle and intermediate schools, with a 13 priority given to schools with the greatest need that have no 14 school-based programs. 15 SECTION 2. The department of health shall issue a report 16 to the legislature no later than twenty days prior to the 17 commencement of the Regular Session of 2007 on the impact of state funds allocated for all department substance abuse 18 19 programs in the regular legislative sessions of 2005 and 2006. 20 SECTION 3. There is appropriated out of the general

- 1 award grants of not more than \$150,000 each to community
- 2 coalitions that are using evidence-based models or best
- 3 practices to provide prevention services specifically in areas
- 4 that do not have existing resources.
- 5 SECTION 4. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$352,220, or so much
- 7 thereof as may be necessary for fiscal year 2006-2007, to fund
- 8 the administration and coordination of the substance abuse grant
- 9 program, including the monitoring and tracking of grant
- 10 resources, through the department of health alcohol and drug
- 11 abuse division.
- 12 SECTION 5. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$1,817,500, or so
- 14 much thereof as may be necessary for fiscal year 2006-2007, for
- 15 adolescent school-based substance abuse treatment programs in
- 16 middle and intermediate schools, with a priority given to
- 17 establishing programs in schools with the greatest need.
- 18 SECTION 6. The sums appropriated shall be expended by the
- 19 department of health for the purposes of this Act.
- 20 SECTION 7. This Act shall take effect on July 1, 2006.
