A BILL FOR AN ACT

RELATING TO INTERNATIONAL MATCHMAKING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 489N-1, Hawaii Revised Statutes, is		
2	amended by amending the definition of "marital history		
3	information" to read as follows:		
4	""Marital history information" means a declaration of the		
5	person's current marital status, the number of times the person		
6	has previously been married, the number of domestic abuse orders		
7,	of protection issued against the person, and whether any		
8	previous marriages occurred as a result of receiving services		
9	from an international matchmaking organization."		
10	SECTION 2. Section 489N-2, Hawaii Revised Statutes, is		
11	amended to read as follows:		
12	"[+]§489N-2[+] Dissemination of criminal record and		
13	marital history information. (a) Each international		
14	matchmaking organization doing business in this State shall:		
15	(1) Notify all recruits that criminal history record		
16	information and marital history information is		
17	available upon request;		

1	(2)	Provide the notice required by paragraph (1) in the
2		recruit's native language and display it in a manner
3		that separates it from other information, is
4		conspicuous, and in lettering not less than one-
5		quarter of an inch high; [and]
6	(3)	Upon request, disseminate to a recruit in the
7		recruit's native language all criminal conviction
8		information and marital history information in the
9		possession of the international matchmaking
10		organization relating to a Hawaii resident about whor
11		any information is provided to the recruit $[-]$;
12	(4)	Require the Hawaii resident to submit or authorize
13		access to the resident's criminal history and marital
14		history information upon requesting the services of
15		the international matchmaking organization; and
16	(5)	Submit an annual report on its business activities to
17		the department of commerce and consumer affairs.
18	(b)	Upon receipt of a request for criminal conviction or
19	marital h	istory information from a recruit, an international
20	matchmaki	ng organization shall refrain from providing any
21	further s	ervices to the recruit or the Hawaii resident with
22	regard to	facilitating future interaction between the recruit

1	and the Hawaii resident until the Hawaii resident has submitted		
2	to the organization:		
3	(1)	The complete transcript of any criminal history record	
4		or a statement that there is no record of convictions;	
5		provided that these are obtained from the Hawaii	
6		criminal justice data center based on a submission of	
7		fingerprint impressions and sent directly to the	
8		organization by the Hawaii criminal justice data	
9		center; and	
10	(2)	The Hawaii resident's marital history information,	
11		accompanied by an affirmation by the Hawaii resident	
12		that any marital history information provided is	
13		complete and accurate and includes information	
14		regarding marriages, annulments, [and] dissolutions,	
15		and the number of domestic abuse orders of protection	
16		issued against the person that occurred in other	
17		states or countries."	
18	SECT	ION 3. Section 489N-3, Hawaii Revised Statutes, is	
19	amended to	o read as follows:	
20	"[+];	§489N-3[] Jurisdiction. (a) An international	
21	matchmaki	ng organization shall be deemed to be doing business in	
22	Hawaii if it contracts for matchmaking services with a Hawaii		

- 1 resident or is considered to be doing business under any other
- 2 law of this State.
- 3 (b) Notwithstanding any other law to the contrary, Hawaii
- 4 residents using the services of an international matchmaking
- 5 organization shall be subject to the laws of this state."
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect on January 1, 2007.
