14	SECTION 3. Section 708-839.8, Hawaii Revised Statutes, is				
15	amended to read as follows:				
16	"[§708-839.8] Identity theft in the third degree. (1) A				
17	person commits the offense of identity theft in the third degree				
18	if that person [makes]:

20	indirectly, a transmission of any personal

4	<u>(b)</u>	Intentionally or knowingly possesses, without

10	<u>(2)</u>	an affirmative defense that the person who			
11	possessed	the confidential personal information of another			
12	did so under the reasonable belief that the person was				
13	authorized to possess the confidential personal information				
14	of another by the other person.				
15	[(2)] <u>(3)</u>	Identity theft in the third degree is a class C			
16	felony. "				
17	SECTION 4.	Statutory material to be repealed is bracketed

19	SECTION 5.	This Act shall take effect upon its approval.
