## A BILL FOR AN ACT

RELATING TO CONTROLLING INVASIVE SPECIES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 150A, Hawaii Revised Statutes, is 1 2 amended by adding two new sections to be appropriately designated and to read as follows: 3 "§150A-A Inspection, quarantine, and eradication service 4 charge. (a) The department shall prescribe a schedule of 5 6 service fees and charges and collect appropriate service fees or 7 charges for invasive species inspection, quarantine, and eradication services from any person who imports any article or 8 9 means of conveyance. The department shall establish a schedule of service fees and charges to ensure that the service is 10 commensurate with the costs of inspection, quarantine, and 11 12 eradication services. (b) Any person who imports an article or means of 13 conveyance shall pay the service fees or charges to the 14 department before the article or means of conveyance is moved 15

from a port of entry in the State.

- 3 SECTION 2. Section 150A-2, Hawaii Revised Statutes, is
- 4 amended by adding two new definitions to be appropriately
- 5 inserted and to read as follows:
- 6 ""Article" means any material or tangible object which
- 7 could harbor invasive species, including plants, plant products,
- 8 soil, boxes and containers, vehicles, baggage, or packing
- 9 material used in connection with the movement of plants, plant
- 10 products, or animals.
- "Means of conveyance" means any personal property used for
- 12 or intended for use for the movement of any other personal
- 13 property."
- 14 SECTION 3. In codifying the new sections added by section
- 15 1 of this Act, the revisor of statutes shall substitute
- 16 appropriate section numbers for the letters used in designating
- 17 the new sections in this Act.
- 18 SECTION 4. New statutory material is underscored.
- 19 SECTION 5. This Act shall take effect on July 1, 2006.
