The sums hereinabove may be paid to the respective persons, or for the satisfaction or settlement of the 11 12 respectively identified cases, and in several amounts 13 hereinabove set forth or in lesser amounts deemed appropriate, 14 upon checks issued by the comptroller; provided that the 15 departments shall obtain the approval of the attorney general **16** before payment of any claim can be made. **17** SECTION 6. Notwithstanding the sums hereinabove stated as 18 interest upon judgments against the State, payment of interest 19 shall be limited to the period from the date of judgment, if 20 applicable, to thirty days after the effective date of this 21 part, as provided in section 662-8, Hawaii Revised Statutes, for 22 those cases to which the statute applies.

- 2 SECTION 7. All unexpended and unencumbered balances of the
- 3 appropriations made in this Act as of the close of business on
- 4 June 30, 2007, shall lapse.
- 5 SECTION 8. If any provision of this Act, or the
- 6 application thereof to any person or circumstance is held
- 7 invalid, the invalidity does not affect other provisions or
- 8 applications of the Act, which can be given effect without the
- 9 invalid provision or application, and to this end the provisions
- 10 of this Act are severable.
- 11 SECTION 9. This Act shall take effect upon its approval.
