A BILL FOR AN ACT

RELATING TO THE HAWAII EDUCATOR LOAN PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 304-20.6, Hawaii Revised Statutes is
2	amended to read as follows:
3	"§304-20.6 Hawaii educator loan program; special fund. (a)
4	There is created the Hawaii educator loan program to be
5	administered by the University of Hawaii, for the purpose of
6	providing financial support to students who complete a state-
7	approved teacher education program and who agree to teach in the
8	Hawaii public school system[+] including Hawaii charter schools.
9	Eligibility shall be awarded by the University of Hawaii to
10	students on a competitive basis. The amount to be loaned to a
11	student shall be determined by the board of regents based on need
12	for financial aid and proof of acceptance into [a] any state-
13	approved teacher education program [at the University of Hawaii.]
14	recognized by the Hawaii teacher standards board. The maximum
15	amount of loans that a student may receive under this program
16	shall be an aggregate amount equivalent to tuition payments and
17	costs of textbooks and other instructional materials necessary to
18	complete a state-approved teacher education program.

1	(b) There is created in the treasury of the State, the
2	Hawaii educator loan program special fund, for the purpose of
3	providing loans pursuant to subsection (a). All loans made under
4	this section shall bear interest at five per cent simple
5	interest. Repayment of principal and interest charges shall
6	commence one year after graduation or three months after a
7	borrower ceases to be enrolled in the state-approved teacher
8	education program and shall be paid in periodic installments
9	within a six-year period. The university may charge late fees
10	and all other reasonable costs for the collection of delinquent
11	loans. The following may be deposited into the special fund:
12	appropriations made by the legislature, private contributions,
13	repayment of loans, including interest and payments received on
14	account of principal, and moneys from other sources; provided
15	that:
16	(1) Moneys on balance in the special fund at the close of
17	each fiscal year shall remain in that fund and shall not
18	lapse to the credit of the general fund; and
19	(2) An amount from the special fund not exceeding five per
20	cent of the total amount of outstanding loans may be set by
21	the university to be used for administrative expenses
22	incurred in administering the special fund.

1	The university may adopt rules to implement the hawair

in, the written contract."

as certified by the department of education who has met 1 2 standards as set forth by the Hawaii teacher standards 3 board. Liability for repayment of a loan shall be canceled upon the 4 5 death or permanent total disability of the borrower. 6 If a loan recipient subject to this section fails to teach in the Hawaii public school system including charter schools for a minimum of [ten] six consecutive years from the 8 loan recipient's original date of employment with the department 9 10 of education, excluding sabbatical and other forms of temporary 11 leaves of absence, then the loan recipient shall repay any 12 remaining loan balance at the rate of ten per cent simple 13 interest. In accordance with chapter 103D, the university may 14 15 enter into written contracts with collection agencies for the 16 purpose of collecting delinquent student loans. All payments collected, exclusive of a collection agency's commissions, shall 17 18 revert, and be credited, to the loan fund. A collection agency that enters into a written contract with the University of 19 Hawaii for the collection of delinquent student loans pursuant **20** 21 to this section, may collect a commission from the debtor in

JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO THE HAWAII EDUCATOR LOAN PROGRAM.

PURPOSE:

To increase the number of qualified teachers in Hawaii's public schools by appropriating funds into the Hawaii educator loan program special fund, and allowing monies in the fund to be used to attend any Hawaii teachers standards board state approved teacher education program. The measure also allows recipients to teach in public schools and charter schools in shortage and difficult to fill school-level instructional teaching positions, and requires a six-year commitment to teach in the public or charter school.

MEANS:

Amend chapter 304-20.6, Hawaii Revised Statutes; appropriate \$500,000 for fiscal year 2006-2007 to the Hawaii educator loan program special fund.

JUSTIFICATION:

The Hawaii educator loan program was established by Act 307 in 2001. The program received a one-time appropriation of \$100,000, and no funds have been appropriated since 2001. This program provides the structure to offer financial assistance to individuals who desire to teach in public and charter schools in Hawaii but who lack the financial resources. The proposed amendments will appropriate \$500,000 into the fund to provide financial assistance to prospective teachers who agree to teach in public or charter schools for six consecutive years. The amendments also allow recipients to use the financial assistance to attend any state approved teacher education program recognized by the Hawaii This added flexibility teachers standards board. would increase the pool of qualified teacher candidates for public and charter schools.

The general fund recommendation included in this measure has been made in accordance with the statutorily defined appropriation ceiling for the Executive Branch pursuant to section 37-92, Hawaii Revised Statutes. Including appropriations made up

to and including the regular and special sessions of 2005 and the Executive Supplemental Budget for fiscal year 2006-2007, the Executive Branch appropriation ceiling for fiscal year 2006-2007 has already been exceeded by \$103.6 million, or 2.1 percent. Funding requested in this measure for the Hawaii Educator Loan Program will result in the appropriation ceiling for the Executive Branch to now be exceeded in fiscal year 2006-2007 by \$500,000 or .010 percent. This current declaration takes into account additional general fund appropriations authorized for fiscal year 2006-2007 in this measure only, and does not include other general fund appropriations for fiscal year 2006-2007 that may be authorized for the Executive Branch in other legislation submitted to the Legislature during the regular session of 2006.

Impact on the public: Increased financial assistance and flexibility for individuals who are interested in teaching in Hawaii public and charter schools.

Impact on the department and other agencies: The department of education and the charter school administrative office will work to identify shortage and difficult to fill school-level instructional positions.
