PURPOSE:

To authorize the use of moneys from the State Highway Fund for the road systems of the

counties for fiscal year 2005-2006.

MEANS:

Enactment of a session law to authorize the use of moneys from the State Highway Fund for the road systems of the counties for fiscal

year 2005-2006.

JUSTIFICATION:

Act 178, Session Laws of Hawaii 2005, appropriated a total of \$10,000,000 for fiscal year 2005-2006 from the State Highway Fund to the City and County of Honolulu (\$4,000,000), the County of Hawaii (\$2,000,000), the County of Maui (\$2,000,000), and the County of Kauai (\$2,000,000), as subsidies for county road work. However, the State Highway Fund, section 248-9, Hawaii Revised Statutes, authorizes the use of the State Highway Fund moneys only for the state highway system. It does not authorize the use of such moneys for

Consequently, to allow the expenditure of Act 178's \$10,000,000 appropriation for fiscal year 2005-2006 from the State Highway Fund to the counties without violation of section 248-9, corrective legislation needs to be enacted prior to June 30, 2006, the lapse date of such funds. This bill, a session law, would permit the expenditure of State Highway Fund moneys by the counties for the road systems of the counties for fiscal year 2005-2006.

Impact on the public: The moneys from the State Highway Fund would be used by the counties for their road systems, which would contribute to a safer driving environment.
