- 4 at Manoa school of nursing and dental hygiene, a center for
- 5 nursing."
- 6 SECTION 2. Section 304D-5, Hawaii Revised Statutes, is
- 7 amended to read as follows:
- 8 "[4] §304D-5[4] Center for nursing special fund. There is
- 9 established [in the treasury of the State] a center for nursing
- 10 special fund into which shall be deposited any legislative
- 11 appropriations, federal or private grants, and any other funds
- 12 collected for the purposes of this chapter. [The] This fund
- 13 shall be administered by [the board of regents of] the University
- 14 of Hawaii, and moneys in the fund shall be expended to support
- 15 the center's activities."
- 16 SECTION 3. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.

PURPOSE:

Clarify that the Center for Nursing is established at the University of Hawaii at Manoa and that the special fund for the Center for Nursing is administered by the

University of Hawaii.

MEANS:

Amend sections 304D-1 and 304D-5, Hawaii

Revised Statutes.

JUSTIFICATION:

This technical amendment clarifies that the administration of the special fund is within the University of Hawaii, rather than the Board of Regents, allowing for efficient and effective management of the fund.

These amendments clarify that this fund is under the authority of the University of Hawaii. It removes unnecessary references to the Board of Regents for consistency with other funds of the University of Hawaii. This clarifies the administrative authority of the School of Nursing and Dental Hygiene and simplifies the funding mechanism for administrative efficiency and effectiveness.


