A BILL FOR AN ACT

RELATING TO A ONE CALL CENTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 269E-4, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: "[+](a)[+] The commission shall establish a one call 3 center advisory committee as a governmental entity as defined 4 under chapter 662D to advise the commission in implementing this 5 chapter. The committee shall consist of [fifteen] sixteen 6 7 voting members and one ex officio nonvoting member. Of the voting members: 8 [Nine] Ten shall be appointed by the commission to 9 (1)10 serve until successors are appointed by the 11 commission. The appointments shall be as follows: One from the gas utility industry; 12 (A) 13 (B) One from the electric utility industry; 14 One from the water utility industry; (C) 15 $[\frac{(C)}{(C)}]$ (D) One from the telecommunications utility 16 industry; 17 $[\frac{D}{D}]$ (E) One from the pipeline operator industry;
