BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$, or so much thereof as may be necessary for fiscal year 2006-2007, for 3 4 a grant-in-aid to the department of the prosecuting attorney of the city and county of Honolulu for the career criminal 5 prosecution unit, including the hiring of necessary staff. 6 7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$, or so 9 much thereof as may be necessary for fiscal year 2006-2007, for a grant-in-aid to the department of the prosecuting attorney of 10 the city and county of Honolulu for the victim witness 11 assistance program, including the hiring of necessary staff. 12 13 SECTION 3. The sums appropriated in sections 1 and 2 shall be expended by the city and county of Honolulu for the purposes 14 of this Act. 15 16 SECTION 4. There is appropriated out of the general 5 revenues of the State of Hawaii the sum of \$, or so 6 much thereof as may be necessary for fiscal year 2006-2007, for 7 a grant-in-aid to the department of the prosecuting attorney of 8 the county of Maui for the victim witness assistance program, 9 10 including the hiring of necessary staff. SECTION 6. The sums appropriated in sections 4 and 5 shall 11 be expended by the county of Maui for the purposes of this Act. 12 SECTION 7. There is appropriated out of the general 13 14 revenues of the State of Hawaii the sum of \$, or so much thereof as may be necessary for fiscal year 2006-2007, for 15 a grant-in-aid to the office of the prosecuting attorney of the **16** county of Kauai for the career criminal prosecution unit, **17** 18 including the hiring of necessary staff.
