A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to create a state 1 eminent scholars special fund to enable the University of Hawaii 2 system to provide donors with an incentive in the form of 3 matching grants for donations to establish permanently endowed 4 faculty positions at any University of Hawaii campus. All funds 5 appropriated for challenge grants, new donors, major gifts, 6 sales tax exemption matching funds, or eminent scholars program 8 shall be deposited into the special fund and invested until the president of the University of Hawaii allocates the funds to the 9 university to match private donations. Any undisbursed balance 10 remaining in the special fund and interest income accruing to 11 the portion of the special fund that is not matched and 12 distributed to the University shall remain in the special fund 13 and be used to increase the total funds available for challenge 14 grants. Funds deposited in the special fund for the sales tax 15 exemption matching program, and interest earnings thereon, shall 16 be maintained in a separate account within the state eminent 17 scholars special fund and may be used only to match irrevocable 18

- 6 SECTION 2. Chapter 304, Hawaii Revised Statutes, is
- 7 amended by adding a new section to be appropriately designated
- 8 and to read as follows:
- 9 "§304- State eminent scholars special fund. (a) There
- 10 is established a state eminent scholars special fund into which
- 11 shall be deposited appropriations made by the state legislature
- 12 and matching private donations. The fund shall be used as a
- 13 funding mechanism to create new endowed faculty positions funded
- 14 by a combination of state and private funds. The board of
- 15 regents shall adopt rules as necessary to establish this
- 16 program. No state appropriations deposited into the fund shall
- 17 be expended unless matched by private funds on a dollar-for-
- 18 dollar basis."
- 19 (b) To be eligible for state matching funds, a University
- 20 of Hawaii campus chancellor shall submit a proposal for each
- 21 proposed endowed chair to the president of the University of
- 22 Hawaii for review and consideration. The president of the

- University of Hawaii shall take into account the following 1 criteria before approving state matching funds to establish a 2 position and recruit candidates: 3 The ability for the position to contribute to Hawaii's 4 (1)economic development; 5 The ability for the position to make a significant 6 (2) contribution to the university's academic quality; and 7 The ability for the position to obtain significant 8 (3) 9 amounts of annual research from highly competitive grant sources. 10 The review process shall consider the field and its (C) 11 potential funding sources, relationship to existing research at 12 the University of Hawaii and in the State of Hawaii, size and 13 scope of related industries, and other relevant factors. 14 (d) The University of Hawaii shall prepare and submit an 15 annual report on the status of the eminent scholars special fund 16 to the legislature twenty days before the convening of each 17 regular session." 18 SECTION 3. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$1, or so much 20 thereof as may be necessary for fiscal year 2006-2007, for the 21

- 4 SECTION 6. This Act shall take effect on July 1, 2006.
