## A BILL FOR AN ACT

RELATING TO SPECIAL NUMBER PLATES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 249-9.2, Hawaii Revised Statutes, is 1 2 amended by amending subsections (a) and (b) to read as follows: 3 In lieu of the number plates contracted on behalf of 4 the counties by the director of finance of the city and county 5 of Honolulu, the director of finance shall provide, for a fee, one set of special number plates upon the receipt of an 6 application together with: 7 8 Specific proof that the applicant was awarded the (1)9 Purple Heart by the United States Department of 10 Defense for wounds received in military or naval 11 combat against an armed enemy of the United States; 12 (2) Certification that the applicant is a veteran; 13 (3) Specific proof that the applicant was serving the United States in the military or as a civilian, on 14 15 Oahu, or offshore at a distance of not more than three miles at the time of the December 7, 1941, attack on 16 17 Pearl Harbor. Certification from the Hawaii state

10		World War II, $[er]$ the Persian Gulf conflict $[r]$ , the
11		Iraqi conflict, or Afghanistan conflict.

19		"FORMER PRISONER OF WAR";
