## A BILL FOR AN ACT

RELATING TO NOISE POLLUTION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 291C, Hawaii Revised Statutes, is		
2	amended by adding a new section to be appropriately designated		
3	and to read as follows:		
4	"§291C- Operation of radios and other soundmaking		
5	devices. (a) No person operating or occupying a motor vehicle		
6	on a public street or highway, or in a public space, shall		
7	operate or amplify the sound produced by a radio, compact disc		
8	player, cassette player, or any other machine or device for		
9	reproducing sound from within the motor vehicle so that the		
10	sound is:		
11	(1) In areas within 100 feet of churches, schools, or		
12	hospitals, louder than necessary for the convenient		
13	hearing by persons inside the vehicle; or		
14	(2) In all other areas, plainly audible at a distance of		
15	thirty feet or more from the motor vehicle.		
16	(b) Any person convicted of a violation of the provisions of		
17	this article shall be punished by a fine of:		
18	(1) \$100 for the first offense;

2		of the first offense; or
3	<u>(3)</u>	\$1,000, or by forfeiture of the sound system or components

9	<u>(5)</u>	Activities of private persons or entities acting

11		city and county, State of Hawaii, or the United

### Report Title:

Motor Vehicles; Prohibited Noise; Radios

#### Description:

Prohibits amplification of noise from motor vehicles plainly audible at a distance of thirty feet or more, or louder than necessary while in areas adjoining churches, schools, and hospitals.
