# A BILL FOR AN ACT

RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 206E, Hawaii Revised Statutes, is
2	amended b	y adding two new sections to part I to be appropriately
3	designate	d and to read as follows:
4	"S206E- Community and public notice requirements;	
5	posting o	n the authority's website; required. (a) The
6	authority	shall adopt community and public notice procedures
7	pursuant	to chapter 91 that shall include at a minimum:
8	(1)	A means to effectively engage the community in which
9		the authority is planning a development project to
10		ensure that community concerns are received and
11		considered by the authority;
12	(2)	The posting of the authority's proposed plans for
13		development of community development districts, public
14		hearing notices, and minutes of its proceedings on the
15		authority's website; and
16	(3)	Any other information that the public may find useful
17		so that it may meaningfully participate in the
18		authority's decision-making processes.

1	<u>(b)</u>	The authority shall notify the president of the senate
2	and speak	er of the house:
3	(1)	Of any public hearing upon posting of the hearing
4		notice; and
5	(2)	With a report detailing the public's reaction at the
6		public hearing, within one week after the hearing.
7	<u>§206</u>	E- Public hearing for decision making; separate
8	hearing r	equired. (a) When rendering a decision regarding:
9	(1)	An amendment to any of the authority's community
10		development rules established pursuant to chapter 91
11		and section 206E-7; or
12	(2)	The acceptance of a developer's proposal to develop
13		lands under the authority's control,
14	the autho	rity shall render its decision at a public hearing
15	separate	from the hearing that the proposal under paragraph (1)
16	or (2) wa	s presented.
17	<u>(b)</u>	The authority shall issue a public notice in
18	accordanc	e with section 1-28.5 and post the notice on its
19	website;	provided that the decision-making hearing shall not
20	occur ear	lier than five business days after the notice is
21	posted.	Prior to rendering a decision, the authority shall

3	(c)	The authority shall notify the president of the senate
4	and speake	r of the house:

### Report Title:

Hawaii Community Development Authority; Public Notice; Oversight

### Description:

Requires HCDA to adopt community and public notice procedures, including posting its proposed plans for development, public notice of its proceedings, and meeting minutes on its website, and providing the public with the opportunity to testify at its decision making hearings. Requires HCDA to notify the Legislature prior to any public hearing, and after the hearing regarding the public's reaction. (CD1)
