A BILL FOR AN ACT

RELATING TO HEALTH INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the use of 2 technology to deliver effective and prompt health care is extremely important in Hawaii, particularly to individuals 3 4 residing in rural communities. The legislature further finds 5 that the need for telehealth services requires that they be 6 reimbursed. The purpose of this Act is to ensure that telehealth 7 services are reimbursed. 8 9 SECTION 2. Section 431:10A-116.3, Hawaii Revised Statutes, 10 is amended to read as follows: 11 "\$431:10A-116.3 [+]Coverage for telehealth.[+] (a) It is the intent of the legislature to recognize the application of 12 13 telehealth as a reimbursable service by which an individual 14 shall receive medical services from a health care provider 15 without face-to-face contact with the provider. 16 (b) For the purposes of this section, "telehealth" means 17 the use of telecommunications services, as defined in section
