A BILL FOR AN ACT

RELATING TO THE OFFICE OF INFORMATION PRACTICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 92, Hawaii Revised Statutes, is amended		
2	by adding to two new sections to part I to be appropriately

5	information practices; complaints. (a) Any person may file an		
6	administrative complaint regarding a board's action based upon a		
7	violation of this part. Upon the filing of a complaint by any		
8	person or at the discretion of the director of the office of		
9	information practices, the office of information practices shall		
10	review or investigate any action of a board for the purpose of:		
11	(1) Requiring compliance with this part;		
12	(2) Preventing violations of this part; or		
13	(3) Determining the applicability of this part to actions		
14	of the board.

Section 92-12, Hawaii Revised Statutes, is 10 11 amended to read as follows: "§92-12 Enforcement. (a) The attorney general [and], the 12 prosecuting attorney, and the office of information practices 13 14 shall enforce this part. The circuit courts of the State shall have 15 **16** jurisdiction to enforce the provisions of this part by injunction or other appropriate remedy. 17 18 (c) Any person may commence a suit in the circuit court of 19 the circuit in which a prohibited act occurs for the purpose of 20 requiring compliance with or preventing violations of this part 21 or to determine the applicability of this part to [discussions

or decisions of the public body.] actions of the board.
