A BILL FOR AN ACT

RELATING TO INCREASING THE LENGTH OF "WALK TIME" FOR PEDESTRIAN CROSSWALK SIGNAL LIGHTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that older adults are at
- 2 a higher risk of pedestrian safety while crossing streets. In
- 3 Hawaii, statistics indicate that the typical victim of a
- 4 pedestrian traffic collision in Hawaii is a Japanese male,
- 5 sixty-five or older, walking in a business district in the early
- 6 morning or early evening.
- 7 Pedestrian patterns are not always easy to identify, in
- 8 part because they do not cluster near particular intersections.
- 9 Instead, they are often spread across long stretches of highways
- 10 or arterial roads with few stoplights, sidewalks, or other
- 11 pedestrian safeguards. Many accidents also appear to fall along
- 12 main bus routes. Statistics illustrate that many accidents
- 13 among Hawaii's elderly occur when they attempt to cross the
- 14 street as a bus approaches.
- 15 The length of a flashing indication (hand symbol) is
- 16 calculated based on the length of the crosswalk and the
- 17 nationally recognized average walking speed of pedestrians.

- 1 Hawaii's elderly have slower than average walking speeds, and
- 2 therefore, need longer time to cross major intersections.
- 3 Hawaii's older adults should feel safe knowing that they are
- 4 under the protection of a crosswalk timer, and should not have
- 5 to rush to cross the street. Unfortunately, this is not always
- 6 the case.
- 7 The purpose of this Act is to reduce traffic accidents and
- 8 fatalities among Hawaii's elderly by increasing the length of
- 9 "walk time" for pedestrian crosswalk signal lights.
- 10 SECTION 2. Section 291C-33, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- 12 "\$291C-33 Pedestrian-control signals. (a) Whenever
- 13 special pedestrian-control signals, exhibiting the words "Walk"
- 14 or "Don't Walk" or the symbols of a walking person or an
- 15 upraised palm are in place such signals shall indicate as
- 16 follows:
- 17 (1) Walk or Walking Person. Pedestrians facing such
- signal may proceed across the roadway in the direction
- of the signal and shall be given the right of way by
- the drivers of all vehicles.
- 21 (2) Don't Walk or Upraised Palm. No pedestrian shall
- start to cross the roadway in the direction of such

1	signal, whether flashing or steady, but any pedestrian
2	who has partially completed the pedestrian's crossing
3	on the Walk or Walking Person signal shall complete
4	the crossing to a sidewalk or safety island while the
5	Don't Walk or Upraised Palm signal is showing.
6	(b) The department of transportation shall adopt rules
7	pursuant to chapter 91 establishing the length of time that a
8	signal described in subsection (a) shall permit a person to
9	cross a roadway, based on factors including, but not limited to,
10	the width of the roadway and the number of lanes; provided that
11	the crossing rate shall be longer than in effect on January 1,
12	2006. All signals, whether under state or county control, shall
13	comply with these rules; provided that nothing in this section
14	or the rules adopted under it shall in any manner adversely
15	impact existing safety procedures, including but not limited to,
16	aid to blind and disabled persons."
17	SECTION 3. There is appropriated out of the general
18	revenues of the State of Hawaii the sum of \$1,000,000, or so
19	much thereof as may be necessary for fiscal year 2006-2007, for
20	adoption of rules setting crossing rates and walk signal time
21	lengths for pedestrian roadway crossing and pedestrian control
22	signals and for resetting walk signal time lengths statewide.

- 1 The sum appropriated shall be expended by the department of
- 2 transportation for the purposes of this Act.
- 3 SECTION 4. New statutory material is underscored.
- 4 SECTION 5. This Act shall take effect on July 1, 2006.
